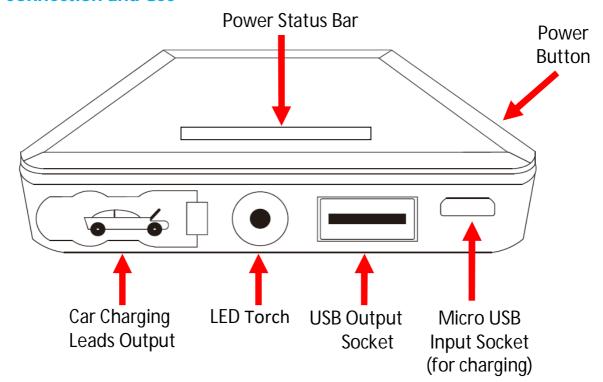

### What's in the box

### **Indicator Lights**

#### On/Off button

To turn the device on, press the POWER BUTTON.

To turn the LED LIGHT on, press the POWER BUTTON twice.

To turn the LED LIGHT off, press repeatedly (refer to the diagram on the back of the battery)

### **Charging the Power Bank**

Using a USB mains powered charger, plug the cable into the PW-CJ6000 (mini-USB end) or you can use the car charger provided, however this will take longer than the mains charger. The LED light display will then start to flash. It is recommended that you charge the unit overnight before the first use, then top up the unit as needed.

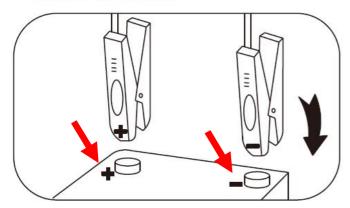

### **Charging from your power bank**

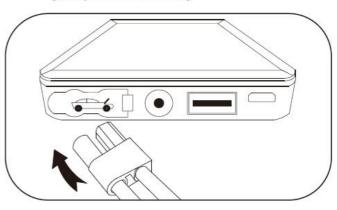
Once you have connected your device for charging (an iPhone for example), press the power button on the power bank. The charging bar on your power bank will then illuminate and charging will begin.

Step 1: Connect positive & negative clips to car battery

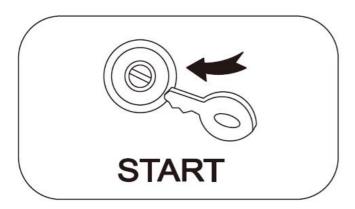


Step 2: Connect battery clips to the jump start battery

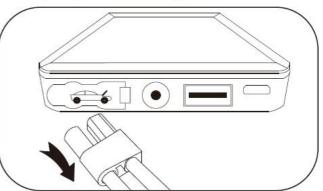


**NOTE: TAKE NOTE OF THE BATTERY POLARITY BEFORE CONNECTING**

#### **Warranty Against Defects**

Step 2a): Contact your place of purchase. They will assess the nature of the fault and repair, replace or fund the product as per their store refund or warranty policy. When we contact you, we will firstly let you know whether you have a valid claim under this Warranty, and if so, we will inform you whether your defective Laser Product will be replaced or repaired, together with the number of days you can expect to wait to receive your replaced or repaired Laser Product.
