三、操作说明



特别提醒: 眼镜第一次与手机连接,需要眼镜进入配对模式。(长按眼镜电源键 5 秒进行蓝牙配对,提示音“已开机,已准备好配对”,指示灯持续快闪。在手机蓝牙列表中搜索“ SPEXETEC ”,单击连接,提示音“已连接”。)

开/关机:

1. 关机时,长按 3 秒开机,提示音“已开机”,指示灯常亮 1 秒。
2. 开机状态(非通话状态),长按 3 秒关机,提示音“即将关机”,指示灯常亮 1 秒。

蓝牙配对连接:

1. 关机状态下,长按 5 秒进行蓝牙配对,提示音“已准备好配对”,指示灯持续快闪。
2. 关机状态下,长按 5 秒进入蓝牙配对模式,连接 2 次电源键,清除配对记录,提示音“已清除配对”。
3. 开机状态下,未连接手机,指示灯每 1 秒快闪 1 次.连接手机后,指示灯关闭。
4. 回连手机时,提示音“正在连接设备”.与手机连接后,提示音“已连接”.与手机连接断开时,提示音“断开连接”。
5. 无配对记录时,开机自动进入配对状态.有配对记录时,开机自动回连最后使用的手机。

播放音乐:

1. 下一曲,快速单击电源键 2 次。
2. 音乐暂停/播放,单击电源键 1 次。

语音助手:

手机已连接,蓝牙待机状态下,快速单击电源键 3 次,启动语音助手,如 SIRI。

打电话:

1. 来电提醒,提示音:“铃铃铃”。
2. 接听电话,单击电源键 1 次。
3. 挂断电话,单击电源键 1 次。
4. 拒接来电,单击电源键 2 次。
5. 通话时,有第三个来电,单击电源键,结束当前的通话并接听第三方电话:双击电源键,保持当前的通话
6. 通话中,长按电源键 2 秒,通话在手机与眼镜之间切换。

充电:

1. 充电时,指示灯常亮.充电完成,指示灯灭。
2. 手机端会显示眼镜的电量(需要手机系统的支持)。
3. 充电温度范围: 0-45℃

四、提示

- 1.使用本产品前请仔细阅读说明书,并保留本说明书。
- 2.首次使用,请先将本产品充满电。
- 3.如果产品长期(超过 2 周)不充电,使用前请对其充电。
- 4.较脏的镜片不要直接擦拭,应先将镜片打湿,再用眼镜布试干.尽量使用绒面且吸水性较强的眼镜布轻轻试干净,注意不要太用力.擦拭时,眼镜布要朝着同一个方向擦拭,也不能在镜片上转着圈擦。

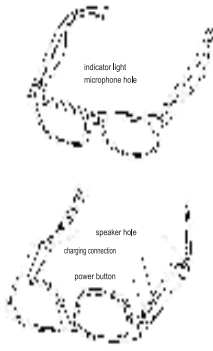

III.Operating Instructions



Important Tips: The glasses need to match the model when to use the product first time. (press the power button for 5 seconds, it will sound “already turn on , ready to match”, the indicator light twinkles. Research” SPEXETEC ” and click connect , it sounds “already connected”

ON/OFF:

1. ON: Press 3 seconds when it's OFF, it sounds“ POWER ON ”, the indicator light on for 1 second.
2. OFF: Press 3 seconds when it's ON(on in the calling state), it sounds“ POWER OFF”, the indicator light on for 1 second.

Bluetooth matching & connected:

1. Press 5 seconds when it's ON, it sounds“ PAIRING MODE”, the indicator light twinkles.
2. Press 5 seconds it will switch to Bluetooth matching mode when it's OFF, press twice power button will delete matching record , it sounds“PAIRING MODE”
3. When it's ON, not connected smart phone, the indicator light twinkle for 1 second, after connected, indicator light out.
4. Reconnected smart phone, it sounds“ connecting”.After connected , it sounds “already connected”. If disconnected, it sounds“ disconnected”.
5. If no matching record, it will automatically into matching state. If there's matching record, it will reconnect the last connected smart phone.

Play Music:

1. Next: quick click power button 2 times.
2. Pause/play: click power button 1 time.

Voice assistance:

When the smart phone connected in Bluetooth state, quick click power button 3 times to start voice assistance , like “SIRI”.

For Calling :

1. Calling reminder, it sounds :” Ling, Ling, Ling”.
2. Short click power button 1 time to get the calling.
3. Short click power button 1 time to hang up.
4. Short click power button 2 times to refuse the calling.
5. Click power button to end the current calling and get the 3rd calling . And double click power button to hold on current calling.
6. When smart phone is busy , click power button 2 seconds to switch between phone and eyeglasses.

Charging:

1. When charging, indicator light keeping on , if completed charging, indicator light out.
2. Power display on smart phone(need smart phone system to support it)
3. Charging temperature :0-45℃

IV.Tips

1. Please read carefully this instructions before using the products and keep the instructions.
2. Please make the eyeglasses in full charging when using it first time.
3. Please charge the eyeglasses first before using it if don't charge it in a long period time (over 2 weeks)
4. Please don't clean the lens directly if the lens are too dirty , should damp it before cleaning with cloth, make sure to use the suede and water – absorbing cloth to clean it slightly, should not too hard. And should be same towards when cleaning, not clean it circling on the lens.

V.Warning

1. Should not dismantle or repair the products in any reason ,otherwise make cause fire ignition, the electrical breakdown and damage the products completely .
2. Should not put the products in the temperature too low or too high (below 0℃ or higher than 45℃)environment.
