b.Connect the cellphone

1.When Bluetooth is connected for the first time, in the shutdown state, long press the multi-function key to the red and blue lights to flicker aiternately and enter the matching state; Non-first connection, automatic connection after boot-up.

2.Open cell phone Bluetooth, search for and click the connection

c. Headphone charging

- 1. When the battery is low, the red light flashes and there is a "beep" tone
- 2. The red light is on when the battery is not full, and the blue light is on when the battery is full.
