

8. Tap 'Start to Connect' when the camera says: 'Receive network configuration and then the camera will be searched and added to the device list.



Note: Some models will not give connection confirmation, please wait about 20 seconds, then the device will automatically added into the list.

Recording on SD Card

Insert the SD card into the camera, Recording will start after the SD card has been recognized and formatted as follows.





10. Tap on 'Settings' when the camera is connected. Then tap 'Device Info'.





11. Set the recording mode to 'Stop recording', then tap 'Format SD Card'.



12. After the SD card is formatted, set the recording mode to All Day Record or Alarm Record, then the recording will start.
