By ordering, accepting, or retaining any products from Monster after receipt of these Conditions or a notice that sales are subject to these Conditions, the distributor, reseller or other customer ("Purchaser") agrees to be legally bound by these Conditions.

#### IF YOU DO NOT AGREE, NOTIFY MONSTER IMMEDIATELY AND DO NOT GO FORWARD WITH THE TRANSACTION.

Price and Product Changes: Prices and products are subject to change at any time unless and until Monster, at its sole discretion, accepts an order specifying certain prices and products.

Orders: Orders must be for \$100 or more, in master carton quantities only and state the entire alphanumeric model name. inventory number and UPC number (reflect last six digits of the full number; first six digits are 050644). Products from Monster Cable Products, Inc. and Monster, LLC must be ordered on separate purchase orders. Monster reserves the right to reject any orders at its sole discretion. Orders are not accepted, until Monster sends Purchaser a written order acceptance or actually delivers the ordered products provided that delivery constitutes acceptance only to the extent Monster actually delivers.

Payment Terms:. Invoices are due and payable within the period specified on the face of invoice, measured from the date of invoice. Purchaser shall identify the invoice number(s) to which its payments shall be applied against.
