How to use Bluetooth with knob

- 1. Use method of adjusting volume: turn the button for a long time without letting go. When turning it to the right, the volume increases. When turning it to the left, the volume decreases.
- 2.Use method of adjusting frequency point: press the knob, when the number on the screen flickers, release it, turn it to the right, it is frequency point increa se, turn it to the left, it is frequency point decrease, when adjusting to the required turn it to the left, it is frequency point decrease, when adjusting to the required frequency point, click the knob again, you can stay on the frequency point to be sclected

With embedded high -performance Bluetooth module and MP3/WMA decoding chip, Audio playbac k can be implemented wirelessly with USB drive, TF and other electronic devices through a car audio.

Moreover, if a cell phone is connected with this product via Bluetooth, hands-fr ee phone call operations during gudio playback can be activated, ad well as a udio playback with cell phone through car audio.

Operating Instructions

1. Bluetooth mode Bluetooth search name: BSXY-6/BSXY-8

- (1) Put this product into the cigarette lighter and synchronize its frequency with that of the car FM radio. Connect this product with a cell phone through Blue tooth.
- (2) Hands-free phone call operations activated: During audio playback, press a button once to answer an incoming call, press that button once again to han g up the call, press that button twice to call a phone number that you dialed la st time. When there is an incoming call, the LCD display will show the telephone number and there is a voice prompt naming the caller's telephone number.
- (3) Through car audio you can hear audio playback from cell phoen,TF,USB d rive and electronic devices via Aux in. You can also hear telephone conversati ons from car audio, as well as the audio messages in cell phone's GPS car na vigation applications.

2. Audio playback mode

- (I) When a TF is inserted, audio playback from TF is activated.
- (2) When an USB drive inserted, audio playback from USB drive is activated.
- (3) When a cell phone or other electronic devices are linked to this product, au dio playback from these devices starts.
- (4) The volume can be adjusted through both bithe buttons on this product and the buttons on car audio.

3. The range of FM frequency

88.1-107.9 MHzWhen the product is on, there is a frequency on the LCD displ ay. To optimize sound quality, set car FM radio to an unoccupied frequency and synchronize this product's frequency to that. Thus car FM radio is successfully paired with this product.

4. Dual USB charging

This product supports dual charging function to cell phone and other electronic devices. You can either charge a electronic device with playing the music in an USB drive, or you can charge 2 electronic devices simulatneously (Note that the charging current of the USB port with a flash mark is 2.1V while that of the UBS port with a USB logo is 1A)

5. Power-off memory

When this product is powered off, it remembers the frequency that is used an d the music in cell phone, TE, USB drive and other electronic devices that is p layed before the it is tumed down, When this product is initiated again, the fre quency will be used and the music will be palyed. However, the first music will be played when you delete or change the memory (cell phone, memory in cel I phone, TF, USB drive and other electronic devices) or when this product dete ct an error slatus.

- 1. This product will connect with cell phone through Bluetooth automatically unless you turn off Bluetooth on cell phone.
- 2.To adjust the volume of car audio use the button on it instead of adjusting the volume through this product. If you use this product to increase the volume of car aduio, do not increase the volume to the highest volume because that can cause distortion.
- 3. This product contains built-in antenna, ao avoid switching to a FM frequenc y with very strong signal or an unoccupied FM frequency in order to get a bett er sound quality.
- 4. Some cell phones may not be automatically cannected with this product thr ough Bluetooth. If that happens, phease manually connect cell phone with this product through Bluetooth.
- 5. When talking on cell phone. Do not raise your voice to an exten that may a nnoy the other party.
- 6. When talking on cell phone, the noise inside of the car may interfere with w he sound quality. Slow down the car or pull over to resume the sound quality. To not use this product in a hot, dusty and wet environment.
- 8. Pull out this product from the cigarette lighter if it is not in use for a long tim e. Put this product into cigarette light after the car engine is started to avoid an y possible damage of high voltage on this product.
