Installing the Receiver (RX)

- 1. Connect the receiver's HDMI to the TV.
- 2. Power the receiver using the USB cable provided into an available USB Type A port or use a 5V DC, 2W max power adapter (Not Included) into a standard power outlet.
- 3. Press and hold the receiver button until the screen says release the button to pair with transmitter.





2. Connection Steps - Continued

Installing the Transmitter (TX)

1. Power the transmitter using the USB cable provided into an available USB Type A port or use a 5V, DC 2W max power adapter (Not Included) into a standard power outlet.

2. Connect the transmitter's HDMI to the

- signal source (e.g., laptop). If you need to use any of the supplied adapters, insert the HDMI into the adapter before connecting to the transmitting source.
- 3 Press and hold the transmitter button for five seconds.
- 4. The LED light will flash rapidly. Screen casting will begin after a few seconds.





3. Pairing Instruction

If the devices do not pair or there is no image, follow these steps:

1.Receiver (Rx)

Press and hold the button on the receiver for 5 seconds.

The screen will display "Ready to Pair".


2.Transmitter (TX)

Press and hold the button on the transmitter for 5 seconds. The status indicator will begin to flash. Once the indicator stavs lit. pairing is complete.
