### Instructions

**Step 1** Rotate the atomizing head clockwise and take it out.

**Step 2** Pour the essential oil into the atomizing bottle.

**Step 3** Tighten the atomizing bottle onto the atomizing head.

**Step 4** Tighten the atomizing head and start using the diffuser.

Note: When adding essential oils, do not exceed the MAX line of the atomizer bottle's capacity.

### Buttons/Indications

Switch	Click to power on/off (The switch indicator light turns on.)
Light/Bluetooth	Click to switch the light color. Bluetooth: Long press for 3 seconds to enter/exit Bluetooth mode (the light turns purple).
Gear	Click to switch gears.
Timer	Click to switch the timing.

Gear I	Work for 15s, pause for 200s
Gear II	Work for 15s, pause for 100s
Gear III	Work for 15s, pause for 60s
Gear IV	Work for 30s, pause for 30s
1H	Shut down after 1 hour.
4H	Shut down after 4 hour.
8H	Shut down after 8 hour.
24H	Shut down after 24 hour.

### Caution/Maintenance

**Safety Instructions**

① If you are not a technician, do not attempt to modify, disassemble, or repair the equipment to avoid damage. In case of abnormal operation, first check if the equipment is used according to proper guidelines or refer to the troubleshooting manual. If the issue persists, contact us via email for after-sales support, and we will handle it appropriately.

② When adding essential oils, do not drip them into the device. Do not invert or tilt the device during use. If the device needs to be transported to another location, first perform maintenance and cleaning on it (see Equipment Maintenance for details), place it properly, and then pack and transport it to avoid damage caused by essential oil leakage. Be sure to maintain and clean the device to ensure it remains in optimal working condition.

**Maintenance**

To ensure optimal diffusion performance of the device, users can inspect and maintain it every six months. Maintenance is also recommended when frequently changing essential oil scents or noticing weakened diffusion effects.

① First, pour an appropriate amount of alcohol into the atomizing bottle for cleaning and let it dry (alcohol is used here as a cleaning agent to effectively remove residues and dirt inside the atomizing bottle).

② After cleaning the atomizing bottle, pour a small amount of alcohol into it again. Tighten the assembled atomizing bottle and atomizing head onto the diffuser, then turn on the device and run it for 5-8 minutes (this step allows alcohol to pass through the atomization system, thoroughly cleaning the precise pipes inside the atomizing head).

③ After the cleaning run is complete, unseal the atomizing bottle and atomizing head. At this point, there may still be residual alcohol on them. Place them in a well-ventilated area to allow the alcohol to dry and evaporate naturally. This step is crucial, as residual alcohol may affect the scent and effectiveness of essential oils used subsequently.

### Prohibitions

Do not by the machine flat or tilt it.

Do not directly drip essential oils into the spray outlet.

## Why isn't the essential oil atomizing? →

When adding essential oils each time, note the following tips.

**Replacement of Essential Oils**

① When adding essential oils, do not exceed the MAX line of the atomization bottle. This is to prevent the essential oils in the bottle from being overfilled, which may cause the oils to surge due to air pressure, potentially submerging the atomization hole, producing gurgling sounds, and affecting the atomization effect.

② Additionally, before and after adding essential oils, turn off the diffuser and let it stand for at least 5 minutes to allow all the essential oils in the atomizing head to flow back into the atomization bottle before restarting the diffuser.

③ Prohibited to pour in other liquid! Do not mix fragrance oils with different ingredients to avoid chemical reactions between components in some inferior oils which may cause corrosion of the atomization core or block the precise atomization system of the diffuser.

If the equipment is blocked and fails to atomize, please refer to the maintenance methods in [Troubleshooting/Maintenance] of this manual for deep cleaning of the atomization pipeline.

### Troubleshooting

1. After powering on, the diffuser does not operate or only runs without atomizing the essential oil.

- ② Check if the machine has a low battery
  - Please connect the power cable to charge.
- ③ During charging-The gear indicator light flashes cyclically.
- Fully charged-The four gear indicator lights are always on.
- Low battery-The gear indicator lights flash three times before turning off and shutting down.

2. Power on, the device runs, but the device no mist/small mist

- ② Check if it is waterless aroma essential oil
  - Add essential oils specifically designed for aroma diffusers. Avoid adding water or using essential oils made for humidifiers or spa treatments.
- ③ Check if the bottle, atomizing head, and body of the machine are tightly screwed
  - The atomization component must be fully tightened; otherwise, the machine will leak air due to incomplete sealing, resulting in the inability to atomize essential oils.
- ③ The atomization component must be fully tightened; otherwise, the machine will leak air due to incomplete sealing, resulting in the inability to atomize essential oils.
- ③ Check if it is outside the working hours set by the Bluetooth App. For example, today is Saturday, and the Bluetooth setting is Monday to Friday; or it is now 8 pm, and the Bluetooth App setting is from 6 am to 6 pm.
- ③ Create a new schedule and save it.

❖ Using for a Period

- ② Check if the machine is blocked. Place your finger on the air outlet to check for spray force.
- ③ Refer to the machine cleaning and maintenance steps, clean the machine regularly.
- ② Check if there is more than 5% essential oil in the oil bottle.
- ③ Add essential oils specifically designed for aroma diffusers.

**The fragrance is not strong enough.**

- ③ Under normal circumstances, our machine can cover an area of 1000-1500 square feet. However, you can enhance the fragrance by following the methods below:
- ③ Choose high-concentration waterless essential oil (recommended not to exceed 85%)
- ③ Re-select the gear button or open the app to reset a longer mist/work time.
- ③ Place the machine near the air intake of the room, and the natural air flow will carry the subtle dry fragrance throughout the space.
- ③ Ensure that there's at least 3 feet of clearance above the diffuser so that nothing is blocking the air from passing over the diffuser and dispersing scent in the room.

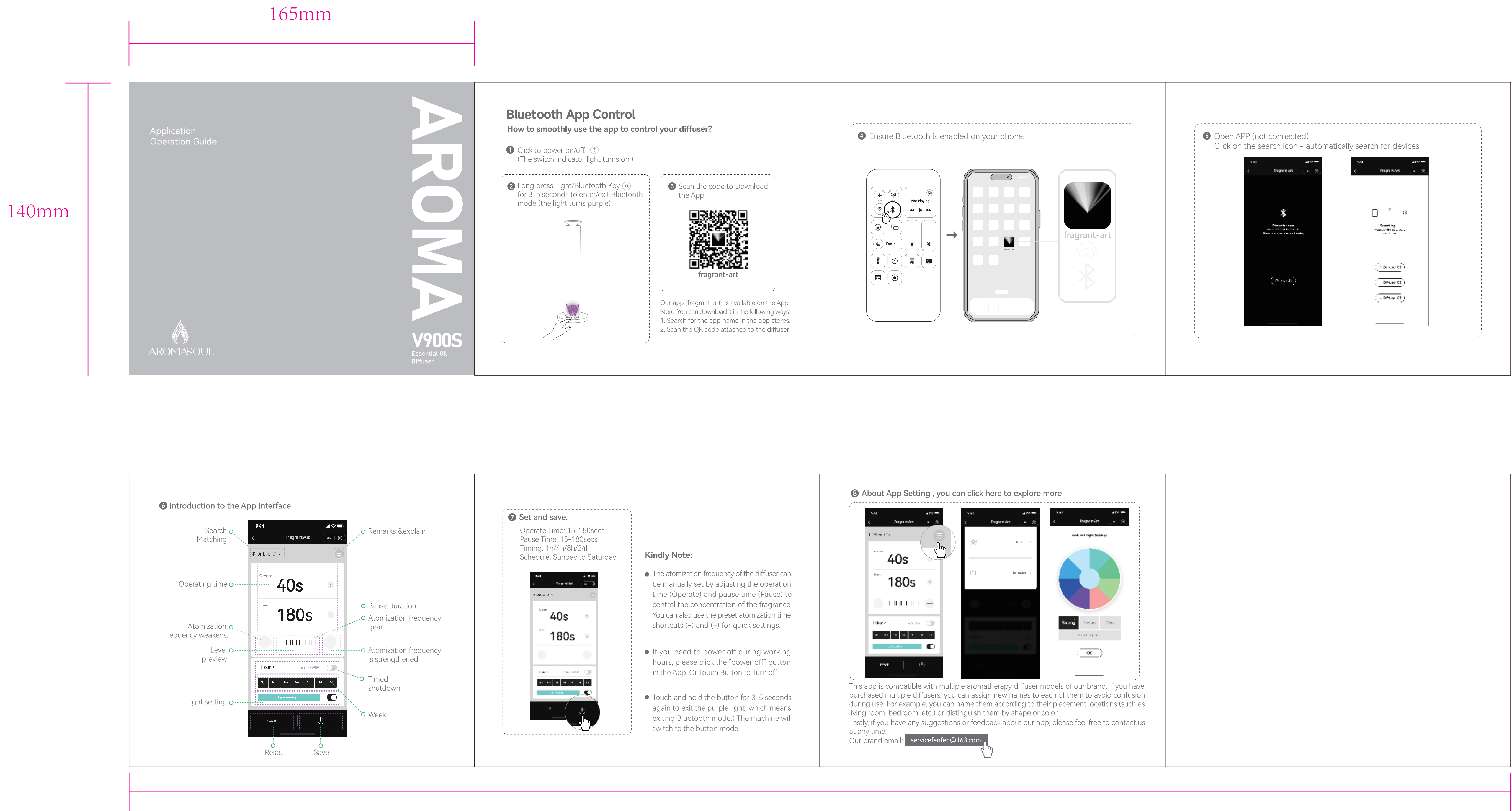
