



Long press for 3 seconds to switch on and off the device, Bluetooth mode will be entered by default, and a Bluetooth mode prompt tone will be played. 2. Press the button to turn on the first gear heating mode, and light up the first gear heating lamp /35 degrees; 3. Press the button again to turn on the 2-gear heating mode, and light up the 2-gear heating lamp /40 degrees; 4. Press the button again to turn on the 3 grade heating mode, and light up the 3 grade heating lamp /45 degrees; 5. Press the button again to turn off the heating 6. Double-click the button to enter the vibration massage mode in the first gear, and the massage indicator light is green; 7. Double click the button again to enter the second vibration massage mode, and the massage indicator light is blue. 8. Double click the button again to turn off the vibration massage mode .</div><div>This machine supports Bluetooth connection; When you need to listen to music or other audio frequency, connect within 3 minutes after starting the machine. The connection method is the same as the universal Bluetooth connection.The default Bluetooth name is CFJG.</div></div>	<div><div>The charging method</div><div>1. When charging, please use a normal charging adapter of 5V/1A or above. 2. Before using the product, please use the charging cable provided by the factory to fully charge the product. 3. When charging, the battery indicator light is bright and blue light is full. 4. The charging time of this product is about 2 hours; Do not charge for a long time, which may affect the service life of the internal mainboard and battery. 5. Low power indicator: The red indicator is steady on.</div><div><div>Maintenance</div><div>1. Clean the skin around the eyes as much as possible before use; If the product is used with wet eye patch, it is recommended to apply the plastic wrap on the surface of the flannelette. 2. This product can be cleaned by toothbrush with a small amount of water or alcohol; After cleaning, place it in a ventilated environment to air dry. 3. The product should not be exposed to sunlight or high temperature for a long time.</div></div></div>	<div><div>Notes</div><div>1. This product adopts lithium battery, which can be used repeatedly after charging; Remember not to keep charging for a long time, it will seriously affect the battery and product life. 2. This product is not in use, please keep in the shutdown state. (A hot compress course of this product is 15 minutes; Automatically turn off the hot compress function after 15 minutes; If you want to continue using, please re-open the hot compress)</div><div>Warning: This product has a hot surface. Use with caution for people who are not sensitive to heat.
