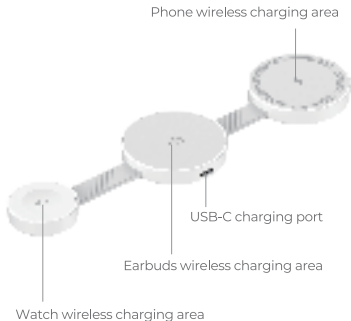

2. This product can wirelessly charge three devices at the same time: phone, earbuds, and watch.
3. The mobile phone wireless charging area supports a maximum of 15W charging, and the fixed-frequency voltage regulation solution will support 5W/7.5W/10W/15W fast charging according to different devices.
4. Folding design, mini size, easy to carry and save space.
