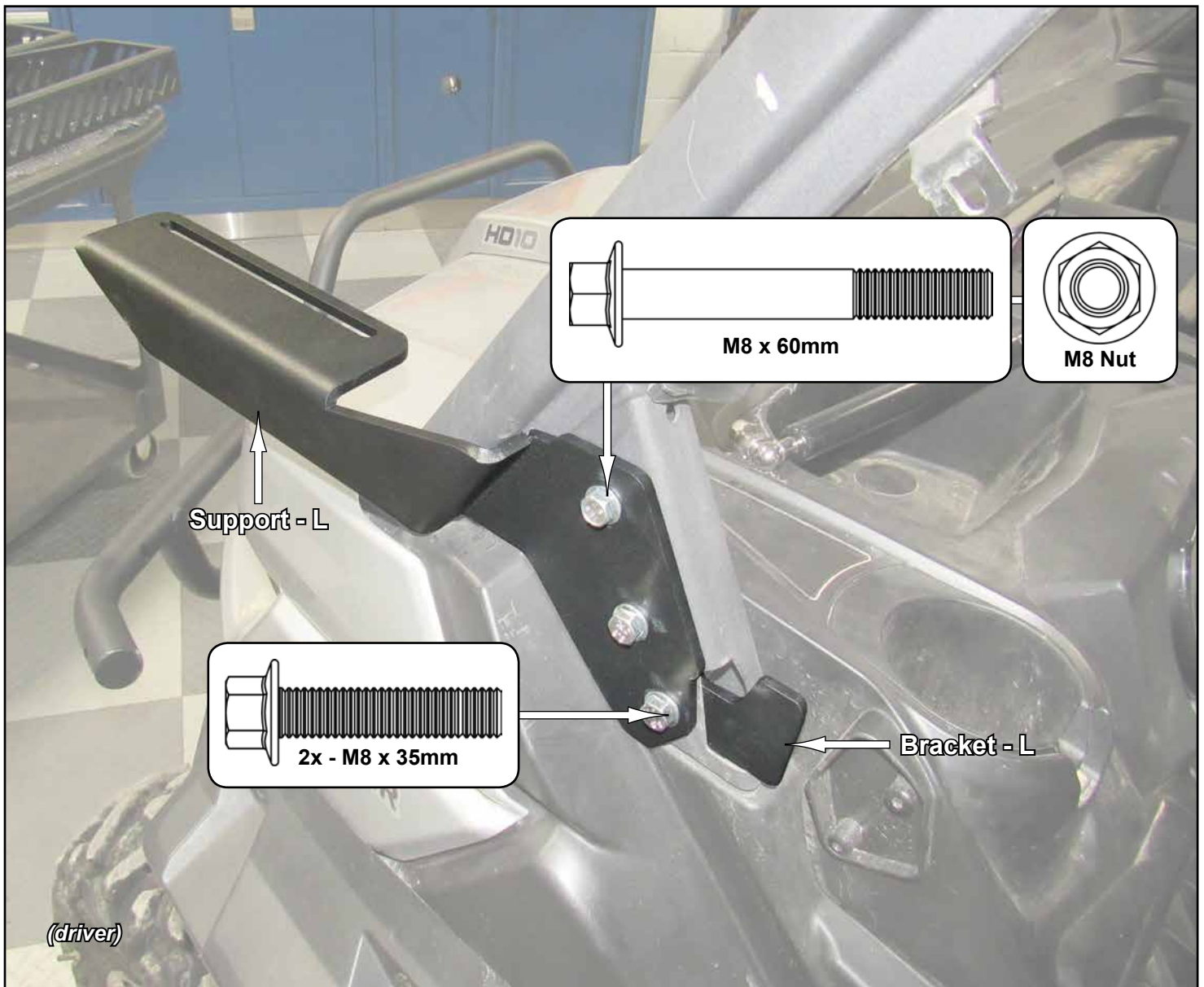

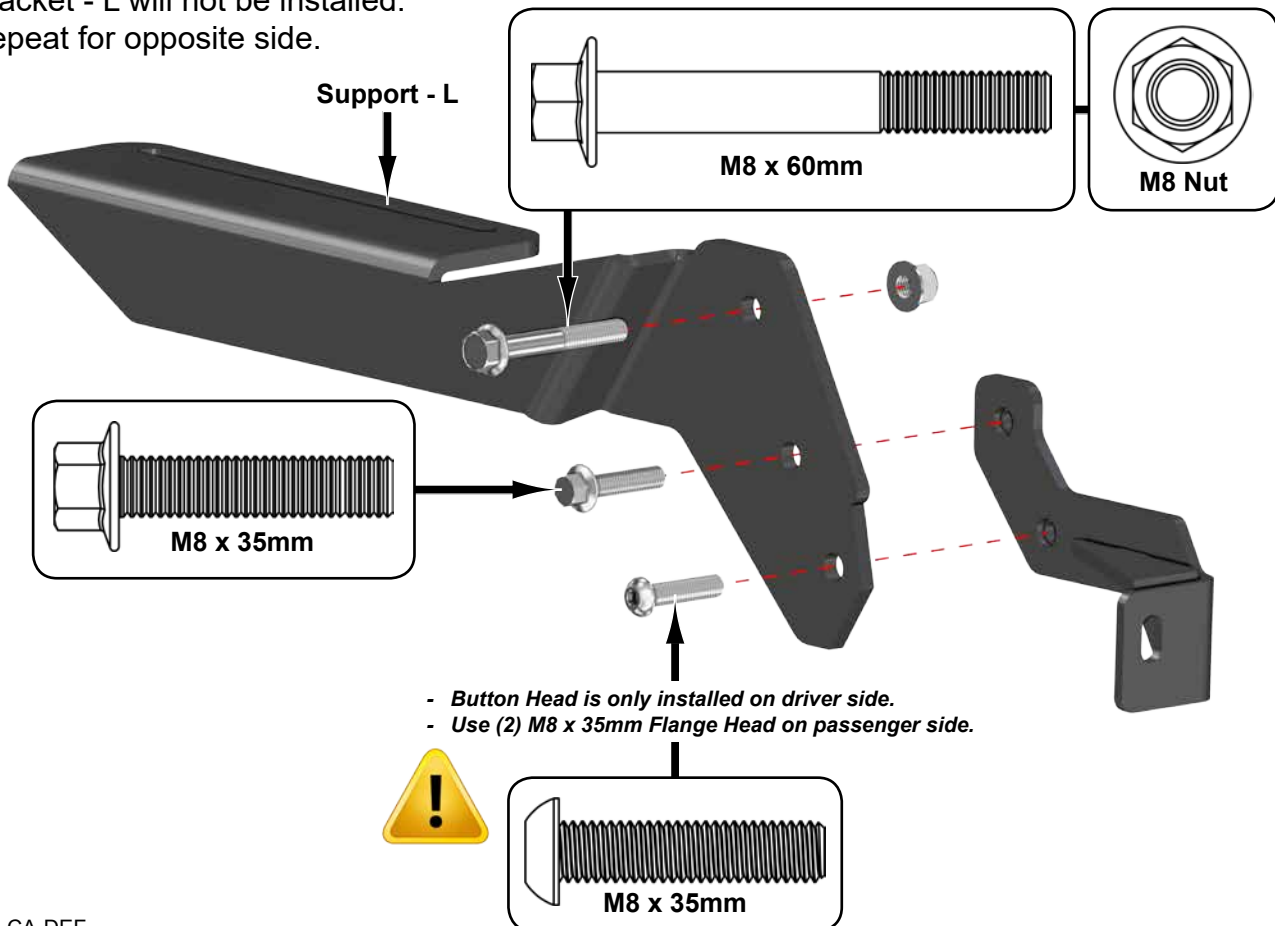

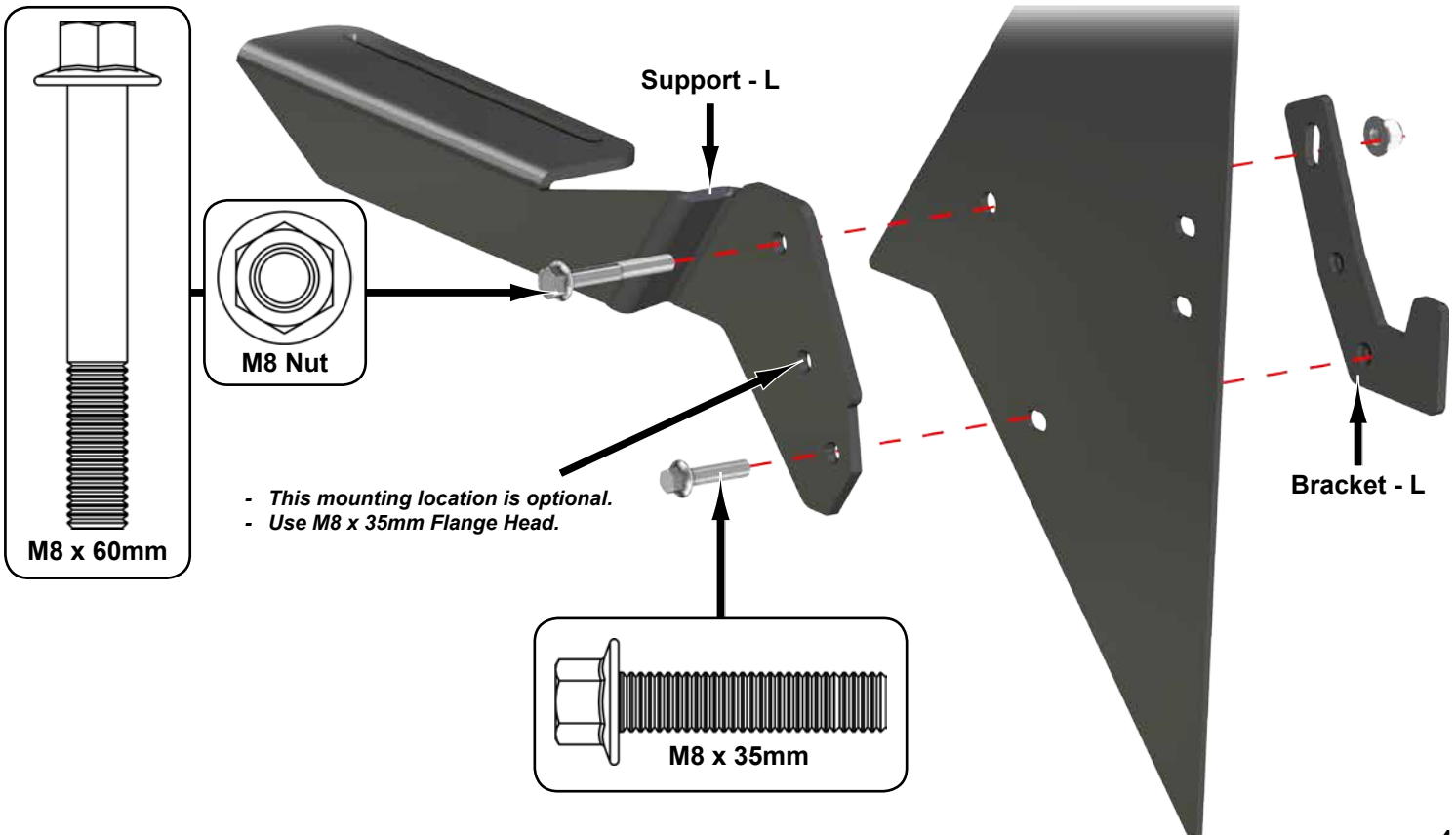
- Install Support - L with hardware shown; tighten hardware.

- Repeat for opposite side.



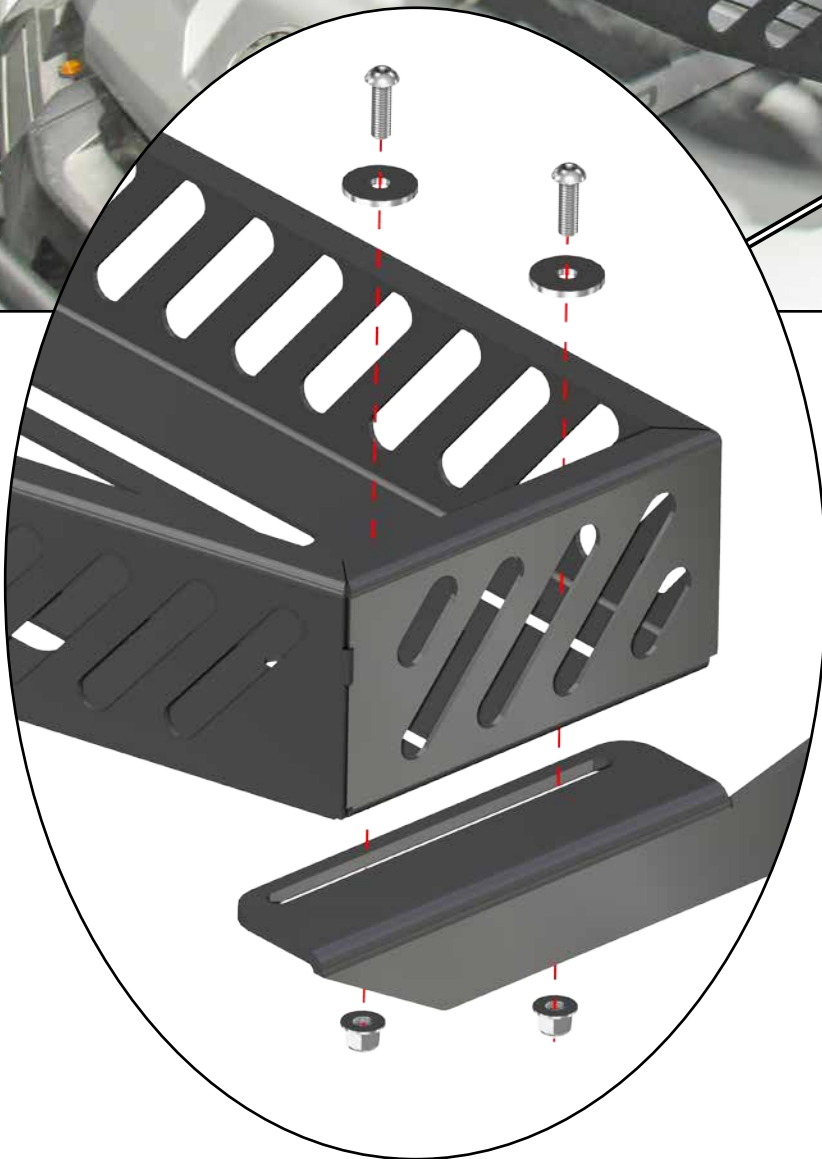
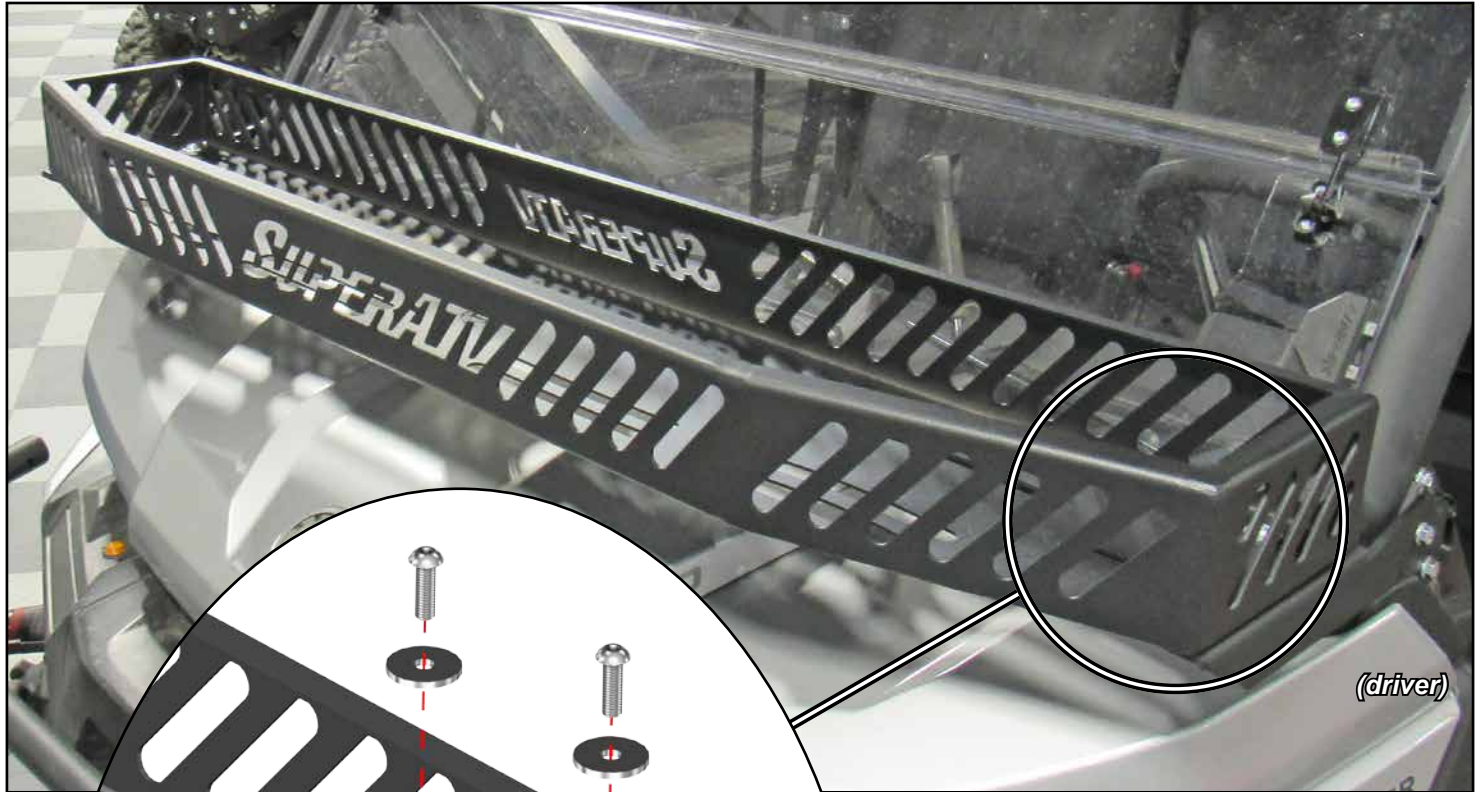
DOOR-CA-DEF-003

- Repeat for opposite side.



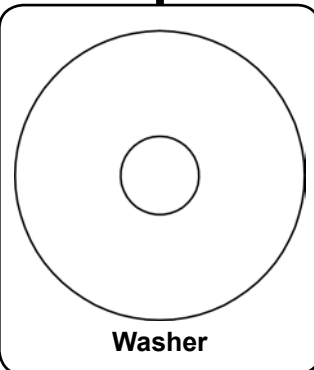
- Install Basket to Supports with hardware shown.
