Introduction & Features

The Actisense NGT-1 makes it possible to send and receive NMEA 2000® data safely between a PC and an NMEA 2000® network. This creates the possibility of feature rich software applications replacing or complementing dedicated hardware such as a Multifunction Display (MFD) or Chart Plotter.

The freely available diagnostic software (NMEA Reader) from Actisense uses the NGT-1 to display all devices active on the network and all of the data messages flowing between them. The powerful set of tools that NMEA Reader offers the user can instil a better understanding of the network and help diagnose potential network issues.

Powering the NGT-1

ISO Variants:

All ISO variants of the NGT-1 receive their power supply when connected to a correctly powered NMEA 2000 backbone. The backbone must also be correctly terminated using NMEA 2000 approved, 120 Ohm termination resistors. Refer to the "Connecting to an NMEA 2000 Network" section for more information.

USB Variants:

All USB variants will be powered by the PC/laptop USB connection once the USB drivers have been successfully installed. Depending on the settings of the PC/laptop that the NGT-1 is connected to, the latest Actisense USB drivers will install automatically from Windows update. If this does not happen, the same USB driver files are available on the CD that is included in the box with the NGT-1 or from the NGT-1 'downloads' web page.

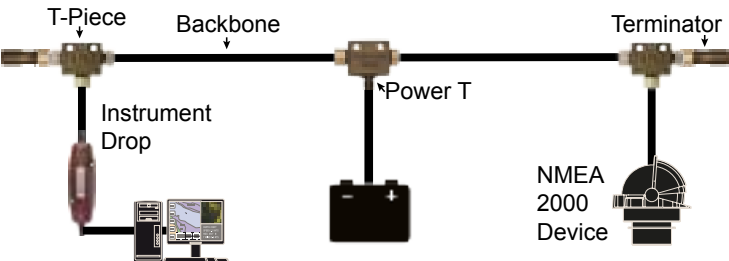

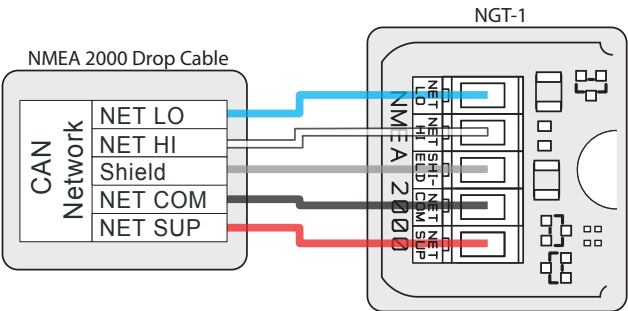
Connecting to an NMEA 2000 Network

The illustration below provides an example of the minimum requirements for an NMEA 2000 network. The horizontal cable joining the T-pieces is not always needed in reality as a backbone can be formed by simply connecting T-pieces directly to each other. The cable connecting a device to a T-piece must not exceed 6 metres as defined in the NMEA 2000 specification:



NMEA 2000 Pin Out

The diagram below illustrates the standard wiring colours used by all NMEA 2000 devices (like the NGT-1):



Wire Colour	NMEA 2000	PCB Label
Shield/Screen	Shield	SHIELD
Blue	Net Low	NET LO
White	Net High	NET HI
Black	Net Common	NET COM
Red	Net Supply	NET SUP

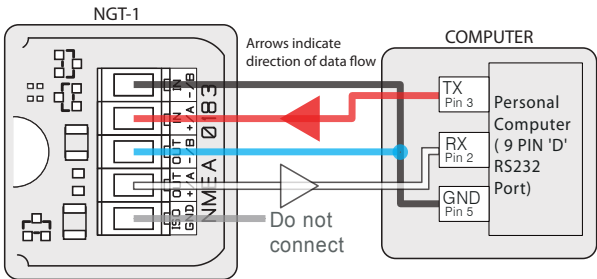
Connecting to a SeaTalkNG Network

Raymarines SeaTalkNG network uses exactly the same data as a standard NMEA 2000 network. The only difference is the physical network connections. To connect any standard NMEA 2000 device (like the NGT-1) to an STNG network, simply use an NMEA 2000 to STNG adapter cable (product code: STNG-A06045) between the device and the STNG network.



Connecting to a PC/laptop

The diagram below illustrates how to connect the loose wires from any ISO variant NGT-1 to a serial cable (DB9F). If the PC/laptop does not have a serial port, a USB-serial converter will also be needed.



Configuring the NGT-1

The Application that is being used with the NGT-1 is responsible for configuring the NGT-1 for each session when it opens up the COM port to the NGT-1. The end user should not need to configure anything, and any manual configuration could be lost.

If the "Tx PGN Enable List" inside the NGT-1 is manually changed those changes may well be overwritten when starting up the software and it configures the NGT-1 to what it knows it needs. Furthermore, if the software in use isn't actually sending the manually enabled PGNs to the NGT-1, nothing will appear on the network. If software has been designed to transmit a PGN it should set up the NGT-1's "Tx PGN Enable List" accordingly to allow those PGNs to be transmitted on the NMEA 2000 network.

LED Behaviour

There are 2 LEDs inside the NGT-1, one on the PC/laptop side, one on the NMEA 2000 network side. On start up, these LEDs will flash alternately and very quickly for 2 seconds.

The primary function of the NGT-1 LEDs is to indicate reception of NMEA 2000 PGN data and the reception of PC/Serial data. If no data is present, both LEDs will flash once every 10 secs (for firmware v2.210) or 5 secs (for firmware v2.500+). This could be a result of incorrect wiring or a lack of data available to the NGT-1.
