DANGER

To reduce the risk of electric shock, burns, fire or injury:

1. Do not use while bathing or in a shower.
2. Do not place or store unit where it can fall or be pulled into a tub or sink.
3. Do not place in, drop or submerge in water or other liquid.
4. Do not reach for unit that has fallen into water. Unplug it immediately.
5. Care should be taken so that objects do not fall and liquids are not spilled onto the unit.

WARNING

1. Close supervision is necessary when this appliance/product is used by or near children or mentally disabled individuals.
2. Use this unit only for its intended use as described in this manual.




- Use only fresh batteries of the required size and type. Do not mix old and new batteries, different types of batteries, or rechargeable batteries of different capacities.


LOCATION OF CONTROLS

INSTALLING THE BATTERIES

1. Open the BATTERY COMPARTMENT door by turning the screw counterclockwise and removing the BATTERY COMPARTMENT cover.
2. Insert 2 AAA batteries according to the polarity indicators.
3. Replace the BATTERY COMPARTMENT cover and replace and tighten the screw by turning it clockwise.



USING THE TV HEADPHONES VIA RCA JACKS

1. Plug the 3.5mm AUDIO TO RCA CABLE into the RCA audio output jacks on your TV.
2. Plug the 3.5mm AUDIO/HEADPHONE CABLE into the audio output jack on the 3.5mm AUDIO TO RCA CABLE.
3. Plug the AC ADAPTER into the DC 12V PORT on the TRANSMITTER and then into a regular 110V wall outlet.
4. Place the TRANSMITTER in a position that will be within the line of sight of the headphones when you are wearing them as you watch TV.
5. Slide the POWER ON/OFF SWITCH on the TRANSMITTER to ON.
6. Turn on the TV and ensure the volume of the TV is turned all the way down.
7. Turn the headphone VOLUME to its lowest setting.
8. Turn on the headphones by sliding the POWER ON/OFF SWITCH on the headphones to ON, and settle them comfortably on your head, adjusting the length of the HEAD BAND accordingly.
9. Adjust the VOLUME on the headphones to enjoy the audio at any volume level privately, without disturbing others—even if you're in the same room!

USING THE TV HEADPHONES VIA HEADPHONE JACK

1. Plug the 3.5mm AUDIO/HEADPHONE CABLE into the audio output jack on your TV.
2. Plug the AC ADAPTER into the DC 12V PORT on the TRANSMITTER and then into a regular 110V wall outlet.
3. Place the TRANSMITTER in a position that will be within the line of sight of the headphones when you are wearing them as you watch TV.
4. Slide the POWER ON/OFF SWITCH on the TRANSMITTER to ON.
5. Turn on the TV.
6. Turn the headphone VOLUME to its lowest setting.
7. Turn on the headphones by sliding the POWER ON/OFF SWITCH on the headphones to ON, and settle them comfortably on your head, adjusting the length of the HEAD BAND accordingly.
8. Adjust the VOLUME on the headphones and your TV to enjoy the audio at any volume level privately, without disturbing others—even if you're in the same room!

Note: The TV volume must be on at an audible level in order to hear sound through the headphones.

TROUBLESHOOTING

PROBLEM	POSSIBLE CAUSE	SOLUTION
Not working and/or no sound.	Objects in between Headphones and Transmitter.	Change your position or clear the line of sight from the Transmitter to the Headphones so there is no disruption.
	Connections between the Audio Jack on the TV and the Transmitter may be loose.	Check all connections.
	You may be out of range of the Transmitter.	Move to within 20 feet of the Transmitter.
	There may be sunlight interfering with the infrared transmission between the Headphones and the Transmitter.	Move away from large windows and make sure there are no sunbeams across the line of sight between the Transmitter and the Headphones.
	Batteries are low.	Replace the batteries.

ONE (1) YEAR LIMITED WARRANTY

Brookstone® warrants this product against defects in materials and/or workmanship under normal use for a period of ONE (1) YEAR from the date of purchase by the original purchaser ("Warranty Period").
