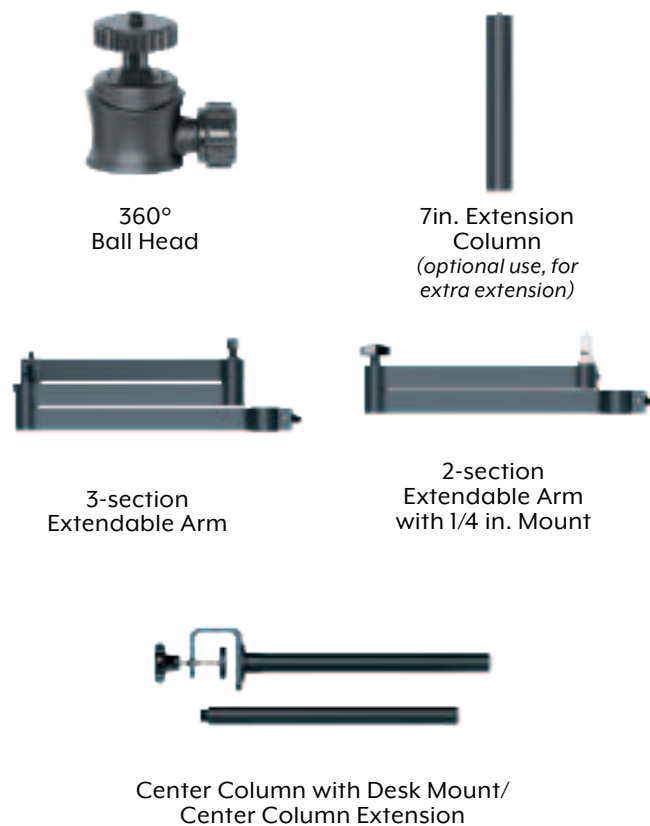




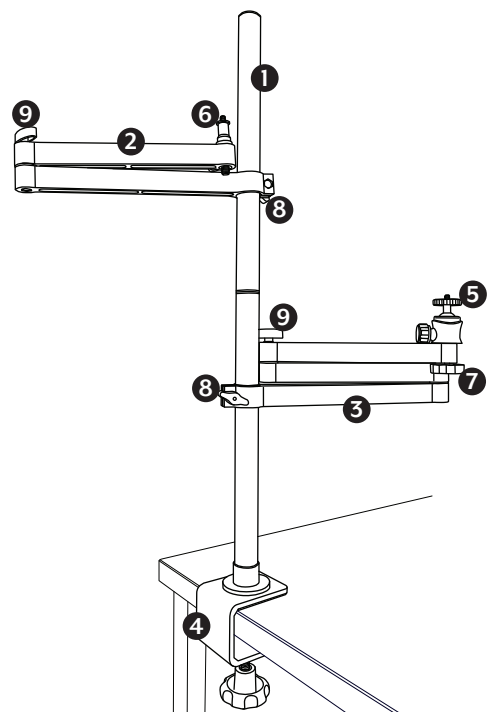

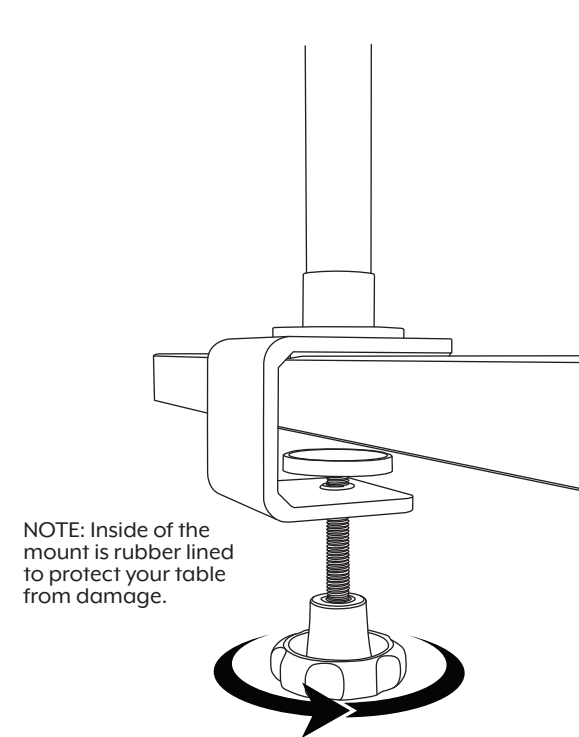


PRODUCT PARTS INTRODUCTION



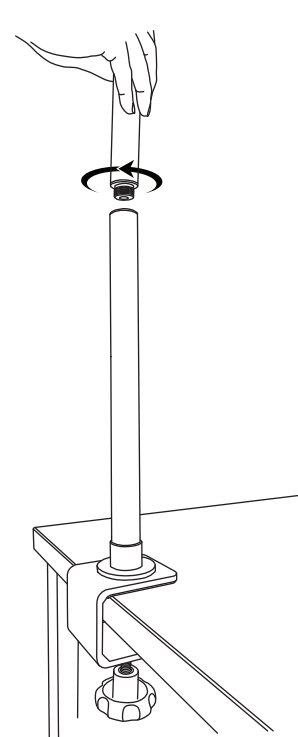
- 1) Center Column
- 2) 2-section Extendable Arm
- 3) 3-section Extendable Arm
- 4) Desk Mount (rubber lined)
- 5) 360° Ball Head
- 6) 1/4 in. Mount (3/8in. screw on bottom)
- 7) Screw Dial (attachment/detachment)
- 8) Locking Screw (secures arm position)
- 9) Locking Screw (secures arm joint position)

INSTALLATION (Center Column with Desk Mount)



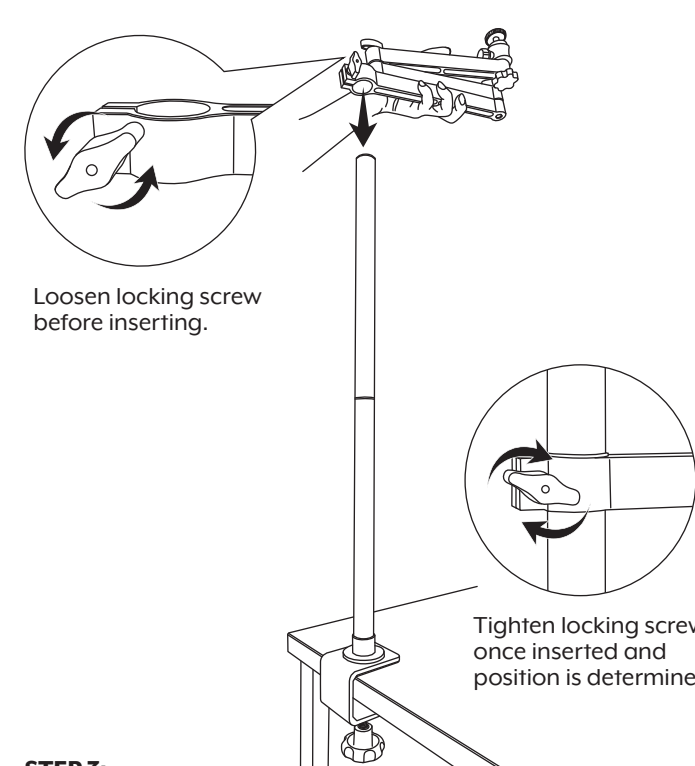
STEP 1:
Mount the Center Column with Desk Mount on to a table/desk and rotate knob until firmly attached. Do not over tighten.

INSTALLATION (Center Column with Desk Mount)



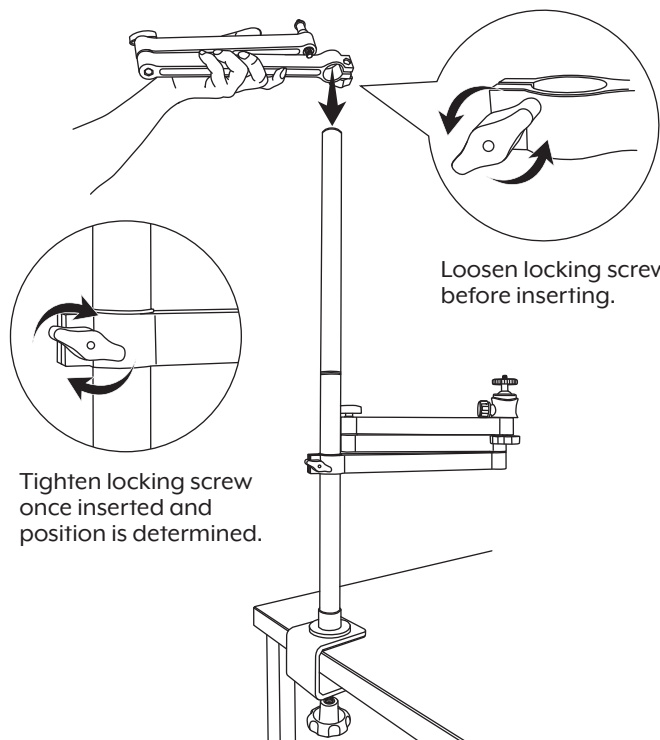
STEP 2:
Attach Center Column Extension by screwing in. Screw in until firmly attached, do not over tighten.

INSTALLATION (3-section Extendable Arm)



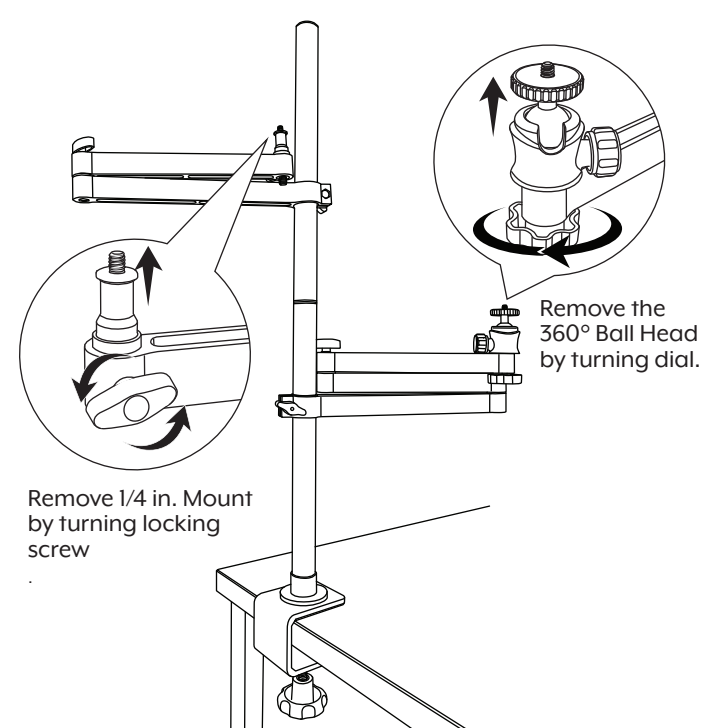
STEP 3:
Loosen the locking screw on the 3-section arm and insert into the center column. Tighten locking screw once desired position is determined. Tighten firmly, but do not over tighten.

INSTALLATION (2-section Extendable Arm)



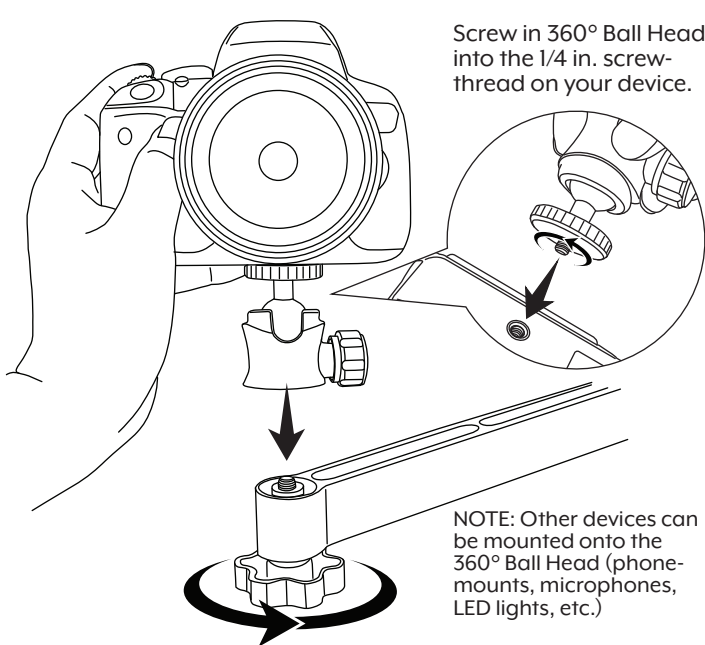
STEP 4:
Loosen the locking screw on the 2-section arm and insert into the center column. Tighten locking screw once desired position determined. Tighten firmly, but do not over tighten.

INSTALLATION (Attaching devices)



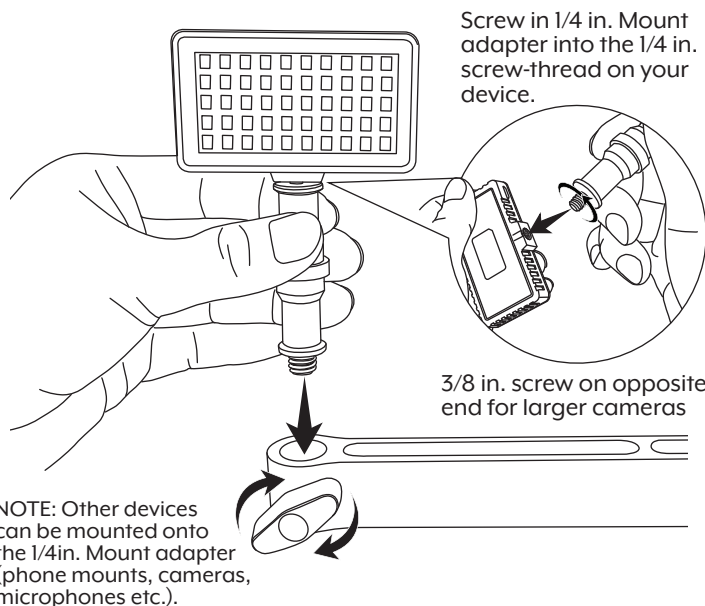
STEP 5:
Remove 360° Ball Head and 1/4 in. Mount adapter from arms by unscrewing. It is recommended that both mounts be removed to attach your devices to them.

INSTALLATION (Attaching devices)



STEP 6:
Once the 360° Ball Head is removed, tighten the dial on it so that the metal ball is firmly set in upright position. Screw in 360° Ball-Head into the 1/4 in. screw thread on your device. Screw in firmly, but do not over tighten. Once the 360° Ball Head is securely attached to your device, attach it to the 1/4 in. screw on the arm by turning the dial on it underneath.

INSTALLATION (Attaching devices)



STEP 7:
Once the 1/4 in. Mount adapter is removed, screw it into the 1/4 in. screw thread on your device. Screw in firmly, but do not over tighten. Once the 1/4 in. Mount adapter is securely attached to your device, attach it to the the arm by inserting inside the socket and turning the locking screw to securely attach.
