Power On/Off

When the device is powered off, long press MFB button for 5 seconds. The white light remains on for 2 seconds, and a system prompt sound will be emitted simultaneously.
When the device is powered on, long press MFB button for 5 seconds, The red indicator light of the headphones will be on for 2 seconds, and a system prompt sound will be emitted simultaneously.

Pairing

In the power off state, long press the MFB button for 5 seconds, After the white indicator light of the headphones turns on for 2

Charging

Please fully charge the headphone before using this device.

Music

Play/pause:short press the MFB button

Previous song:connected phone status, long press the “+” button for 2 seconds

Volume Control

Turn down the volume:connected phone status, press the “-” button
Turn up the volume:connected phone status, press the “+” button

Call

Answer/hang up:short press the MFB button
Reject the call:long press the MFB button for 2 seconds
Cancel a call:when the caller does not answer, press the MFB button twice

2.4G Dongle

There is a pairing record. After inserting the 2.4G dongle into the computer, the white light flashes slowly (the white light flashes quickly if there is no pairing record). The connection with the headphone is successful and the white light remains constantly on

Voice Assistant

Connected phone status, press the MFB button twice

Reset and turn on the headphones.

When the headphones are turned off or abnormally do not power on, long press MFB button for 10 seconds to force the headphones to power on

Reset

When the headphones are powered on but not connected, press the MFB button five times quickly. After clearing the pairing record between the headphone and the mobile phone, the headphones will automatically shut down.

Low Battery

The red light flash, and the Bluetooth headphone icon in the phone's status bar turns red

Responsible for your hearing
