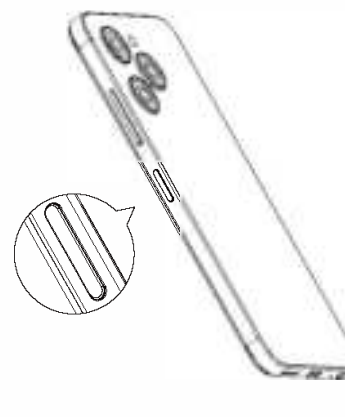

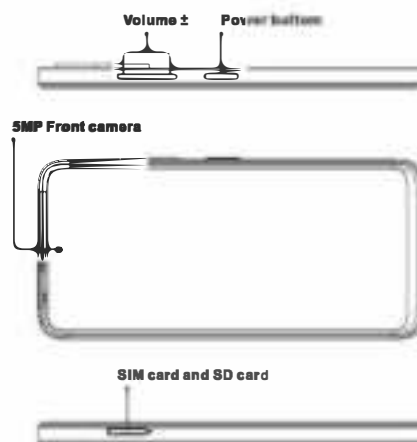

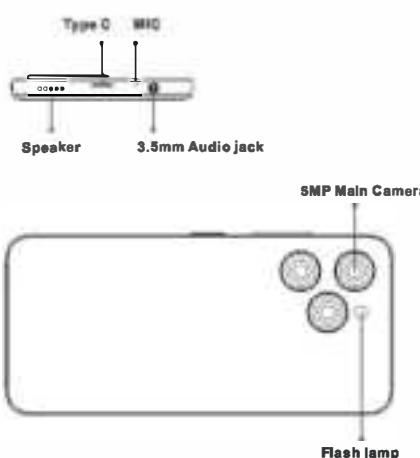
## FCC RF Exposure Information and Statement
