

Kernel Global Infrastructure (NZD Hedged) Fund

Fund update for the quarter ended 30 June 2025

This fund update was first made publicly available on 28 July 2025.

What is the purpose of this update?

This document tells you how the Kernel Global Infrastructure (NZD Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel Global Infrastructure (NZD Hedged) Fund is a is designed to provide diversified exposure to pure-play infrastructure companies domiciled globally. The index covers all sectors of the infrastructure market. To be included in the index, a company must derive at least 70% of cash flows from infrastructure lines of business. The Kernel's Hedged Global Infrastructure Fund is also hedged to New Zealand Dollar. It is suitable for an investor with an investment time horizon of at least 5 years.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2024 and did not make any further contributions. On 30 June 2025, Emma received a return after fund charges were deducted of \$2,207 (that is 22.07% of her initial \$10,000). This gives Emma a total return after tax of \$2,151 for the period.
