



Instructions for installation



Device resetting

Press and hold the toggle button for 5 seconds within one minute after powering on the device. When the device breaths in blue light, it will start to restore the factory settings. When the light changes to rainbow streamer, it means that the device has been successfully reset.


* When used in a new network environment, restore factory settings before reconnecting the network.



* Press and hold the toggle button for 5 seconds within one minute after powering on the device.

Guideline for network

- 1. Download the Yeelight Station mobile client from the mobile app store.
- 2. Ensure that the device has been powered on and reset successfully. (Notice: If network distribution is not completed for a reset device, the device will automatically close the network distribution window, which will be opened again after re-powering or resetting the device.)



3. Turn on the app, and follow the instructions in the app to scan the Matter QR code on the cover of the manual or on the product's control box, or enter the resetting code underneath the Matter QR code, thus completing the network access operation.


