PBX FINDER is designed for the convenience of users, simplifying daily life, allowing you to say goodbye to lost belongings and enjoy a peace of mind lifestyle.</p><div><div>Button Function</div><div>Power On</div><p>Tap the button once and hear 1 beep (1 tick).</p><div><div>Power Off</div><p>Press and hold the button (about 5s) to hear 3 prompt sounds (3 ticks) and release.</p><div><div>Factory Reset</div><p>Click 3 times in a row + long press the 4th time to hear a long beep tone.</p></div></div><div><div>How to Pair</div><p>Note:iOS or iPadOS version 14.5 or above.</p></div></div></div>	<div><div></div><div><div>(Figure 1)</div><div>(Figure2)</div><div>( Figure3 )</div></div><div><div>1.1 Place the FINDER next to your Apple device like iPhone.</div><div>1.2 Turn on bluetooth on iPhone and connect to Internet.</div><div>1.3 Press the button of the PBX FINDER once to turn on the device.</div><div>1.4 Open the 'Find My' app.</div><div>1.5 In 'Find My' app, Tap '+', then 'Add Other Item'. See Figure 1.</div><div>1.6 Once your FINDER is located, tap 'connect '. See Figure 2.</div><div>1.7 Enter a name and choose an emoji for your FINDER and tap 'Continue'. See Figure 3.</div><div>1.8 Find My will ask for confirmation to add your FINDER to your Apple ID. Tap 'Agree'.</div><div>1.9 Tap 'Finish' and your FINDER will be set up and ready to be used.</div></div><div><div>Battery</div><p>The PBX FINDER contains a CR2032 coin cell battery, during the product's lifespan, it may be necessary to replace the battery. And you should pay attention to the positive and negative electrodes of the battery.</p></div></div>	<div><div>Battery Replacement</div><div>2.1 Force in the opposite direction along the buckle position to separate the upper and lower shells;</div><div>2.2 Replace the battery with a new one, with the positive pole facing up;</div><div>2.3 Align the button position, squeeze inward, and fasten the shell.</div></div> <div><div>Additional Tips</div><div>3.1. When the device is paired with the Find My app, the phone needs to be linked to the Apple server. Pairing failures may occur due to network issues. We recommend the following:</div><div>a. Change the cellular network, such as switching between WIFI and mobile networks;</div><div>b. Factory reset the PBX FINDER;</div><div>c. Re-pairing.</div><div>3.2. To remove PBX FINDER from your Apple device, open the Find My app, select "Items", find the device, then scroll down and tap "Remove this device".</div><div>3.3. Battery life, related to personal usage habits, frequent use of the call function will accelerate battery drain.</div></div> <div><div>Important Matters</div></div>	<div><div>The PBX FINDER contains delicate electronic , including a battery to avoid damage, loss of function, or potential harm.
