


- 1. USB-C to USB-C cable



QUICK SETUP



1. Unscrew the terminals on both speakers. Connect the included speaker wire to the A2+ left (powered) speaker terminal and into the color matching posts on the right (passive) speaker terminal.

Check the speaker wire polarity by verifying that the wires are going to the same terminals on both speakers.

Re-screw the speaker terminals to secure the connection.

POWER

2. Connect the cable from the external power supply to the power supply connection on the A2+ left (powered) speaker rear panel. Be sure to align the pins correctly.



Connect the AC power cord to the other end of the power supply and plug the cord into a functioning power outlet. A light on the power supply should be illuminated.

Turn the volume knob clockwise until you hear a click. The pair light on the rear or the A2+ powered speaker should be illuminated.

WIRELESS CONNECTION

3. If this is your first time setting up Bluetooth, the A2+ will automatically go into Bluetooth "pair mode" and the pair button on the rear panel will start flashing.

On your Bluetooth enabled device, such as a smart phone, turn on Bluetooth and go to Bluetooth preferences.

Select "Audioengine 2+" to pair and connect.

The Pair indicator light on the A2+ powered rear panel should now be solid.

Play your music and adjust the volume on both your speakers and your device to your desired listening levels.
