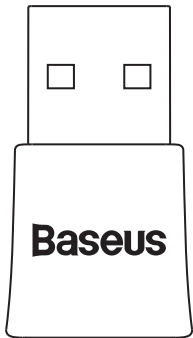

## 常见问题

Q: 是否支持Windows系统免驱安装?

A: 是的, WIN8.1/10/11系统无需安装驱动, 插上即可使用。

Q: 电脑本身带有蓝牙功能, 是否可以使用?

A: 可以, 需要先将电脑本身自带的蓝牙禁用后才能使用。

Q: BA07是否支持自动回连蓝牙设备?

A: 是的, Windows系统都支持回连。

Q: 为什么我的耳机/音箱会出现连接失败或者连接超时?

A: 确保耳机/音箱处于开机状态, 让耳机处于可发现搜索配对状态, 进行配对即可使用。

Q: 其它设备有USB端口, 我的产品是否可以使用?

A: 该产品仅适用于Windows系统, 车内设备与其余等系统均无法使用。

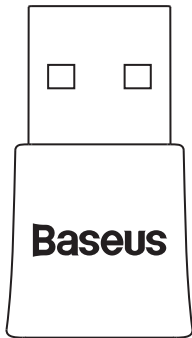

## FAQs

Q: Is it driver-free installation with Windows systems?

A: Yes, it is driver-free installation with WIN8.1/10/11, just plug and play.

Q: Does it still work if the computer already has wireless function?

A: Yes, but you have to disable your computer's wireless first.

Q: Does BA07 have an auto-connection function?

A: Yes, with Windows system it does (after first time successful connection).

Q: Why does the connection fail or time out with my earphones/speakers?

A: Make sure your earphones/speakers are turned on, so that the adapter will find your device for pairing, and they will be successfully connected after being paired up.

Q: Does this product apply to other devices with USB ports?

A: No, this product is only applicable to Windows systems, cannot work with other devices and systems.
