4. USE

- 4.1. Expand the headband until the protective rings surround the ears and the headband sits firmly on the head.
- 4.2. Secure the headband so it sits in the centre of the head and lays flat.

5. MAINTENANCE

5.1. CLEANING

- ✓ Wash with clean water and a household detergent.
- ✗ **DO NOT** use caustic solutions, acids, solvents or strong mechanical cleaning.

5.2. STORAGE

- ✓ Store in a clean, dry place, between 5-40°C, before and after use.
- ✗ Avoid direct sunlight.
