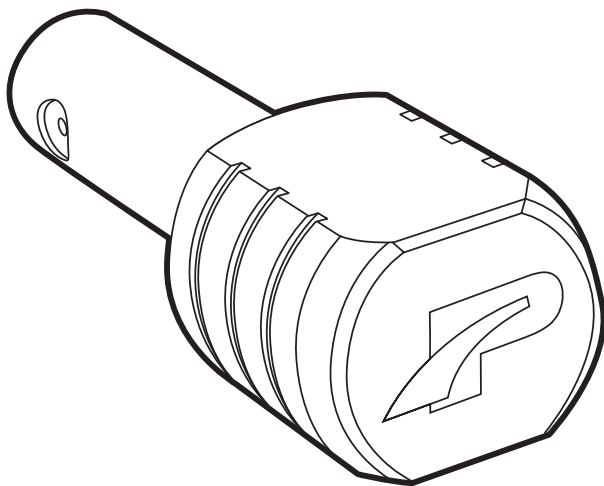
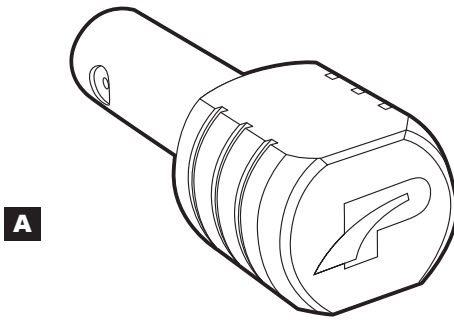

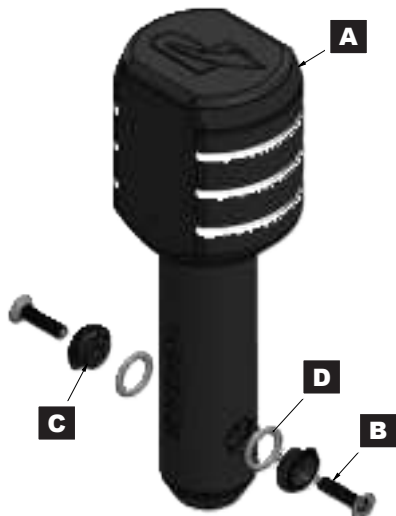

- B** (2) M4 flat head Torx screws
- C** (2) Countersunk washers
- D** (2) Rubber seals





Installation

Step 1: Begin by depressing the two tabs on either side of the stock knob through the holes in the base of the handle Fig. 1 & 2.

Step 2: Use an adjustable wrench to firmly grip the stock knob and rotate it to allow unrestricted movement of the locking tabs. Once done, proceed to remove the knob as shown in *Fig. 3*.

Step 3: Slide the PPE Grab Handle **A** in place and line up the threaded holes with the holes in the base of the handle as shown.

Step 4: Place the rubber seal **D** over the countersunk washer **C** and secure it with Torx Screw **B**, repeat on the other side.
