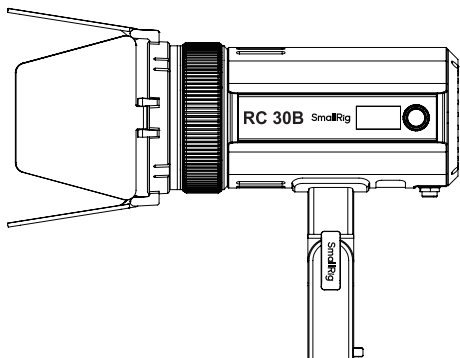

Warnings

1. Please read this User Manual carefully.
2. Keep this User Manual and always include it when passing the product onto the third party.
3. Heed all warnings and follow all instructions in this User Manual.
4. Close supervision is necessary when any fixture is used by or near children. Do not leave the fixture unattended while in use.
5. Care must be taken as burns can occur from touching hot surfaces.
6. Do not operate the fixture if a cord is damaged or if the fixture has been dropped or damaged until it has been examined by qualified service personnel.
7. Position any power cables so that they will not be tripped over, pulled or put into contact with hot surfaces.
8. If an extension cord is necessary, a cord with an amperage rating at least equal to that of the fixture should be used. Cords rated for less amperage than the fixture may overheat.
9. Always unplug the lighting fixture from the electrical outlet before cleaning and servicing or when not in use. Never yank the cord to remove the plug from the outlet.
10. Let the lighting fixture cool completely before storing.
11. To reduce the risk of electric shock, do not immerse this fixture in water or any other liquids.
12. To reduce the risk of fire or electric shock, do not disassemble this fixture. Contact smallrig@smallrig.com or take it to qualified service personnel when service or repair work is required.

14. Power this fixture by connecting it to a grounded outlet.
15. Please do not block the ventilation and do not look at the light directly when it is powered on.

18. Please have the product checked by an authorized service personnel agent if your product has a problem.

20. We recommend only using the original SmallRig cable accessories. Please note that our warranty for this product does not apply to any repairs required due to any malfunctions of unauthorized SmallRig accessories, although you may request such repairs for a fee.

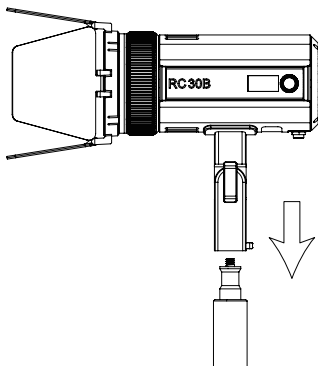


Installation Instruction

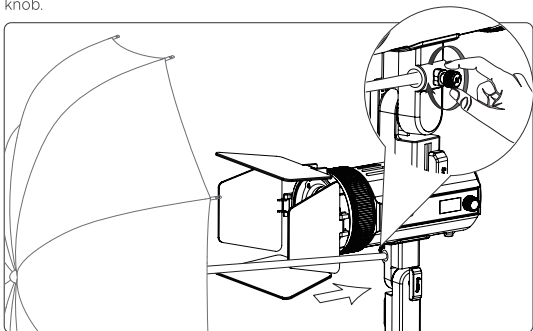
1. Install the 4-leaf barndoor on the light in the direction of the arrows shown.



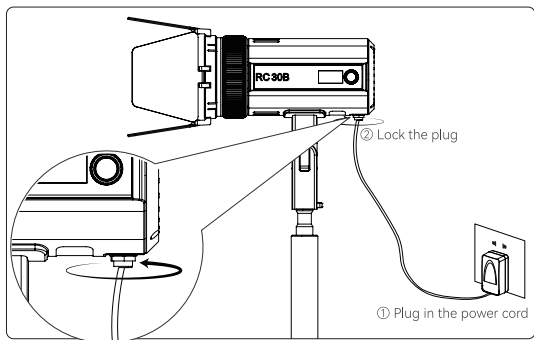
2. Adjust the light to the appropriate Angle and rotate the tightening knob to secure the light on the tripod.



3. Insert the handle of umbrella softbox into into the hole and lock the knob.



Power Supply



Notice: When pulling out the power cable, loosen the locking device on the plug first. Do not pull it out forcefully

Operations

1. Turn on the power and long press the Power button.

2. Light Control.

2.1. Brightness adjustment.

Rotate the CCT / INT knob to adjust the brightness with 1% variable and the brightness change range is 0 ~ 100%, the change of the brightness will be displayed in real time on the monitor.

2.2. Color Temperature Adjustment.

A. Press the CCT /INT knob and switch to CCT mode.

B. The CCT is adjusted between 2700K ~ 6500K.

2.3. Beam Angle adjustment: Adjust the zoom ring in front of the light head to change the light Angle between 15° ~ 60°.
