

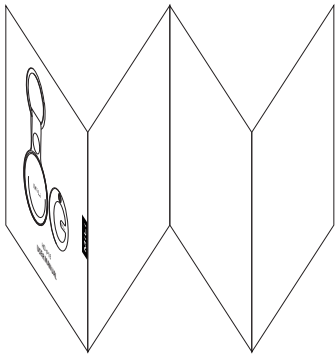

If your item ever goes missing, you can put it in Lost Mode to display a message and contact information to anyone who might find it.The Find My network is encrypted and anonymous, so no one else, not even Apple or the maker of your personal item, can view its location.</p><p>2.
