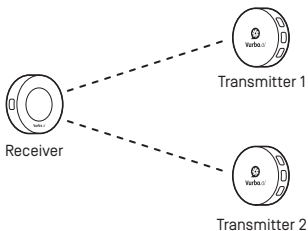
## Start to Use Your IPEVO AI WIRELESS MIC DUO

**Step 2:** Auto-pairs upon turning on.



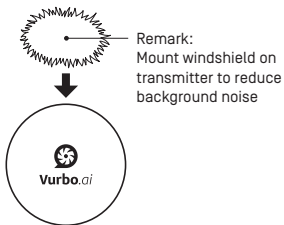
