

Fund update for the quarter ended 30 June 2025

What is the purpose of this update?

This document tells you how the Kernel Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel Balanced Fund's investment objective is to achieve positive real returns over the medium term while lessening volatility through diversification across asset classes, sectors, and geographies.

Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2024 and did not make any further contributions. On 30 June 2025, Emma received a return after fund charges were deducted of \$1,121 (that is 11.21% of her initial \$10,000). This gives Emma a total return after tax of \$979 for the period.

Currency Hedging:

The fund had a 10.25% allocation to the Kernel US Bond Fund which was 98.60% hedged back to New Zealand dollars, a 2.92% allocation to the Kernel Global Property (NZD Hedged) Fund which was 100.30% hedged back to New Zealand dollars, a 3.03% allocation to the Kernel Global Infrastructure (NZD Hedged) Fund which was 99.12% hedged back to New Zealand dollars, and a 18.52% allocation to the Kernel S&P Global 100 (NZD Hedged) Fund which was 99.60% hedged back to New Zealand dollars.
