

# Kernel NZ Commercial Property Fund

### Fund update for the quarter ended 30 June 2025

This fund update was first made publicly available on 28 July 2025.

### What is the purpose of this update?

This document tells you how the Kernel NZ Commercial Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Kernel NZ Commercial Property Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Real Estate Select Index.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.




Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

## Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2024 and did not make any further contributions. On 30 June 2025, Emma received a return after fund charges were deducted of \$977 (that is 9.77% of her initial \$10,000). This gives Emma a total return after tax of \$904 for the period.
