

# **Key Introduction**


- Luminous technology, no glare, no strobe, soft lighting eye protection.

- USB charging function.






# **Directions For Use**




- Light control button: press to turn on/off the lamp light, long press 3 sec to turn on/off LCD display light.

- 60 minutes timer button: press to turn on/off the desk lamp light 60 minutes timer off function.







Light arm can be rotated 1 20 °




Side night light design is convenient to get up at night

How to set the Time and Date?


Single press "S" to enter the setting mode (the hour display flashes to indicate entering the program)

```





When you connect the power supply, both wireless charging and USB output charging can be used normally, you can choose wireless charging or USB output for charging.


Please place the phone that supports wireless charging in the wireless charging area

#### **Product service warranty card**
