

# **Controls**

- To adjust LED brightness: Press the LED BRIGHTNESS button once for 1 second.
- To select language: Press the LANGUAGE SELECT button twice for 1 second each while the power is on.
- To force pairing mode: Press and hold the FORCE PAIRING MODE button for 8 seconds.
- To perform a factory reset: Press and hold the FACTORY RESET button for 8 seconds.
- To enter stereo pair mode: Follow the instructions on the device.
- To enter multi-pair mode: Connect with at least 3 speakers and follow the instructions on the device.

We or us means HoMedics Australia Pty Ltd ACN 31 103 985 717 and our contact details are set out at the end of this warranty; You mean the purchaser or the original end-user of the Goods.
