



Safety Warning


- 1. Before using and operating this device, please read thoroughly and comply with the following precautions in order to prevent accidents or inaccurate operations.

Installation Procedure

Warning: Please make sure the power cord of the Interactive Intelligent Panel is disconnected before installation. Step 1: Tear off the patch. Use a Phillips screwdriver to loosen two screws and remove the cover.



Step 2: Insert the module upward into the platform of Interactive Intelligent Panel in the direction of the arrow.




Step 3 : Complete the connection.


Note: This Wi-Fi module only works for the Interactive Intelligent Panel by plugging it into the above slot.

Software Function

- 1. After installation, open the Interactive Flat Panel and the wireless module will run automatically.
- 2. Click on Settings, on the menu.
- 3. Click on "Wireless Network" and you can turn the wireless network on / off.



4. Click on the " icon to enter the wireless hotspot.
