We are excited to start rolling out our software updates for Mini Med 770G customers wishing to upgrade to Mini Med 780G. This will be done in a phased approach over 3 phases in Q2 2022.

Phase One will be for users that have access to selected compatible devices from Samsung and Google – the Phase One compatible devices can be found here.

If you have not already done so, please take a minute to complete a guick feedback form letting us know which mobile device you have so we can assign you to the correct phase.

If you have access to a device listed as a Phase One compatible device, please indicate that in the form – it does not need to be the device you use with MiniMed Mobile for the update. We can then include you in Phase One. The information we need can be found in your mobile phone as follows:
