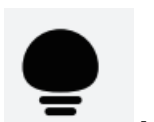

and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and if they understand the hazards involved.

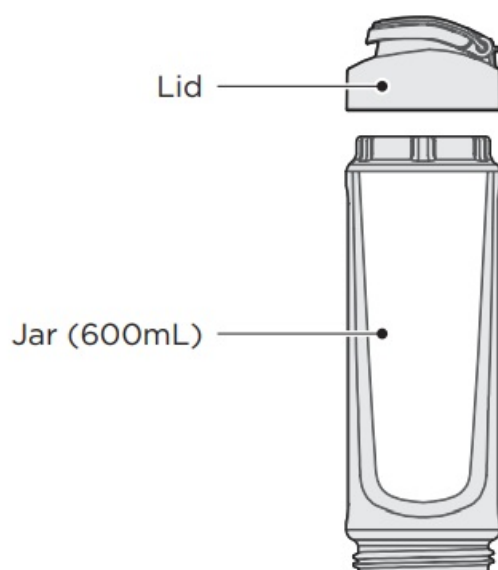
- Children shall not play with the appliance.

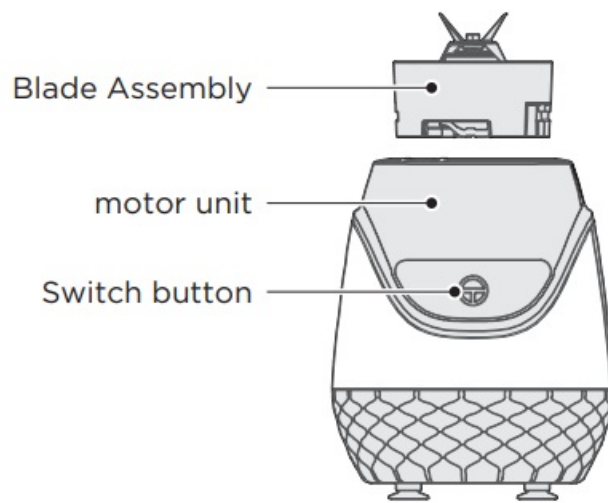

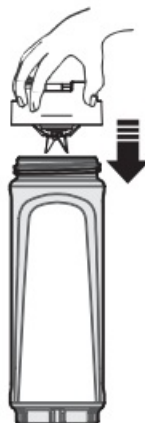




INSTRUCTIONS FOR USE

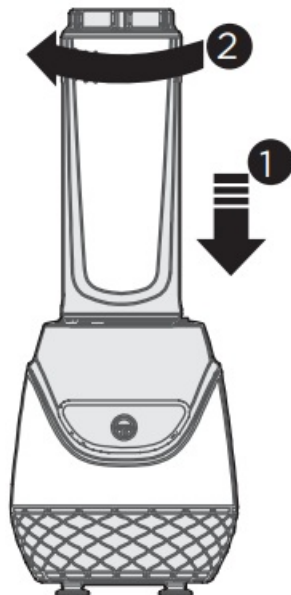
1. Fill the bottle with your favorite ingredients.
Be sure not to fill ingredients over the 600mL marking.



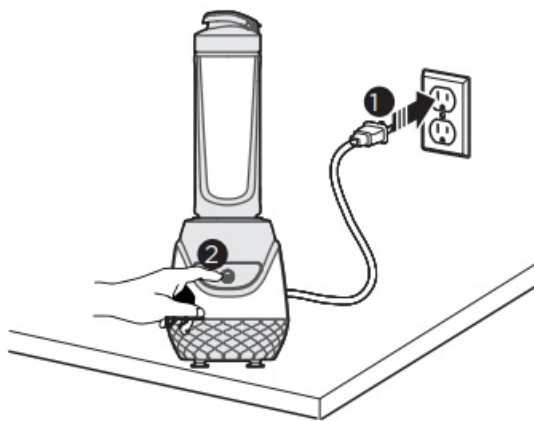
2. Fasten the blade assembly on the open end of the bottle.



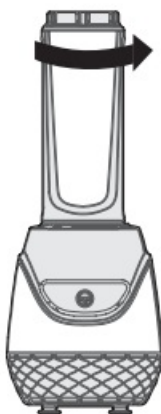
3. Turn the bottle upside down, line up arrow “▲” on the blade assembly to the lock “” on the base, place the bottle in the base by pressing and simply turn the bottle clockwise to lock “” on the base.



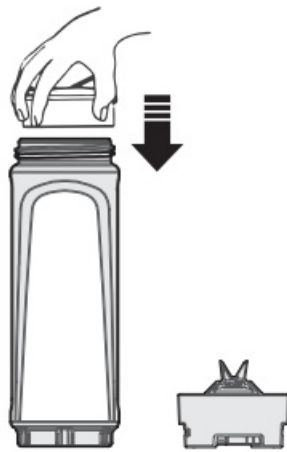
4. Place the blender base on a flat surface and plug in it. Pressing switch button, the blender will start to work, release switch button to stops working.



5. After the ingredients are fully blended, stop the blender working, and turned counterclockwise rotation the bottle, take out the bottle form the base.



6. Remove the blade unit and screw on the lid.



Warning



- Rotating blades can cause severe injury.
- Lids are not interchangeable between different container styles, types, and sizes.
- Machine running time can not be more than 3 minutes. After the shutdown, it is necessary to let it fully heat, cooling to room temperature.

RECIPES

Item	Food	Quantity	Time
1	Carrot juiceJar capacity 600 mL	240g carrot + 360g water	1 mins
2	Crushing ice cubes and water	250g 20mm diameter ice cubes 250g ambient water	1 mins
3	Pineapple smoothie	154g pineapple, skin removed diced, 300mL milk3pcs ice cubes	15 seconds
4	Kiwi smoothie	168g kiwi, peeled diced 3pcs ice cubes, 300mL milk	15 seconds
5	Banana smoothie	1/2 banana, halved 250mL milk1 scoop ice cream 1tbsp honey	15 seconds

CLEANING AND MAINTENANCE

Cleaning

	<ol style="list-style-type: none"> 1. Unplugged from the power source before cleaning. 2. Remove all fittings except the motor unit for leaning in water. Please be careful when cleaning the blade, sharp blade, to avoid being cut.
	<ol style="list-style-type: none"> 1. Use a damp cloth to wipe the surface of the motor unit, with a dry cloth, must not be the motor unit body into water or other solution for cleaning, in order to avoid danger. 2. If the product has any problem in use, after all the parts are dried, the method can be assembled according to the previous method. 3. The product has any problem in use, please do not disassemble by yourself, should immediately contact the nearest authorized service provider or customer service maintenance point detection, maintenance.

TROUBLESHOOTING

Operation of your appliance can lead to errors and malfunctions. The following tables contain possible causes and notes for resolving an error message or malfunction. It is recommended to read the tables carefully below in order to save your time and money that may cost for calling to the service center.

Fault Analysis and Elimination

Symptom	Analysis of Possible Causes	Countermeasure
Product does not work	The jar assembly is not installed in place.	The jar assembly must be closed in place.
	The inching switch is not pressed.	Keep the switch press states.
Blender blade stuck	The amount of processed food is too much.	Reduce the amount of processed food.
	Food sticking the blade.	Switch off electrical power if clean up the ingredients on the clean blade.
The Products found abnormal odor, hot, smoke and other phenomena	The amount of processed food is too much.	Reduce the amount of processed food.
	The product running times too long.	Reduce the motor running times.
	The temperature of the processed ingredients is too high.	Do not exceed 60°C.
Jar drain juice (water)	The blade holder seal is missing or not properly mounted on the tool holder assembly.	Check the blade holder seal states.
	The jar is screwed into the blade holder assembly without tightening.	Check the jar whether on tightening.
	The jar is screwed into the jar cover without tightening.	Check the jar whether on tightening

Abnormality Handling

1. In case of abnormalities such as abnormal noises, smell, smoke, etc., you should immediately cut off power and stop use.
2. If the product cannot work, please check if the power supply is connected, if the switch is put to the ON position and if fittings are installed in place.
3. If the product still cannot work after checks mentioned above, please consult the designated repair centre for maintenance.

A: It is not recommended to blend hot liquids in this blender to avoid potential hazards.

- **Q: How do I clean the blender blades?**

A: To clean the blender blades, detach them from the jar and wash them carefully with warm soapy water, ensuring not to cut yourself on the sharp edges.

- **Q: Can I use ice cubes in this blender?**

A: Yes, you can use ice cubes in the blender, but make sure not to overload the jar beyond the maximum capacity to prevent damage to the blades or motor.
