# **Product display**





## 1. Function keys (power key)

Power on: Press and hold for 3 seconds Power off: Press and hold for 3 seconds Play/Pause: Single click Stop playing: Double click Quick Start: Double click (see "Quick Start" for detailed steps)

Reset Button Reset: Press and hold for 5 seconds in the reset hole

- 2. Status Indicator Light Power on: Green light continuously flashes, waiting for Bluetooth connection Bluetooth connection successful: Green light flashes 3 times then turns off Breathing light: when in standby, the green light slowly changes from dark to bright every 4 seconds, and then from bright to dark Power off: green light flashes quickly 3 times and then goes out Low battery: the power value is detected when the device is turned on, and the red light stays on for 5 seconds when the power is less than 20% Reset: After long pressing for 5 seconds, the green light flashes 2 times Charging: green light flashes Fully charged: green light stays on
- 3. Type-C power interface

To ensure safety, limit the use of devices during charging. If the machine is new or has not been used for a long time, it is recommended to fully charge it before use.

The App will periodically upgrade its software to update features and improve compatibility with more device models and system versions.

When you want to use MindLax M3 more efficiently, you can directly double-click the button on the device (without opening the app) to enjoy the relaxing and sleep-aiding function immediately.

#### **Unlock Method**

After completing the account registration and adding/activating the device in the app, you can unlock the device's "Quick Start" function.

#### **Operating Instructions**

Double-click the function key "Start/Stop" to activate the Quick Start function (when the device is turned on) –
 Single-click the function key "Play/Pause" to activate the Quick Start function (when the device is turned on)
