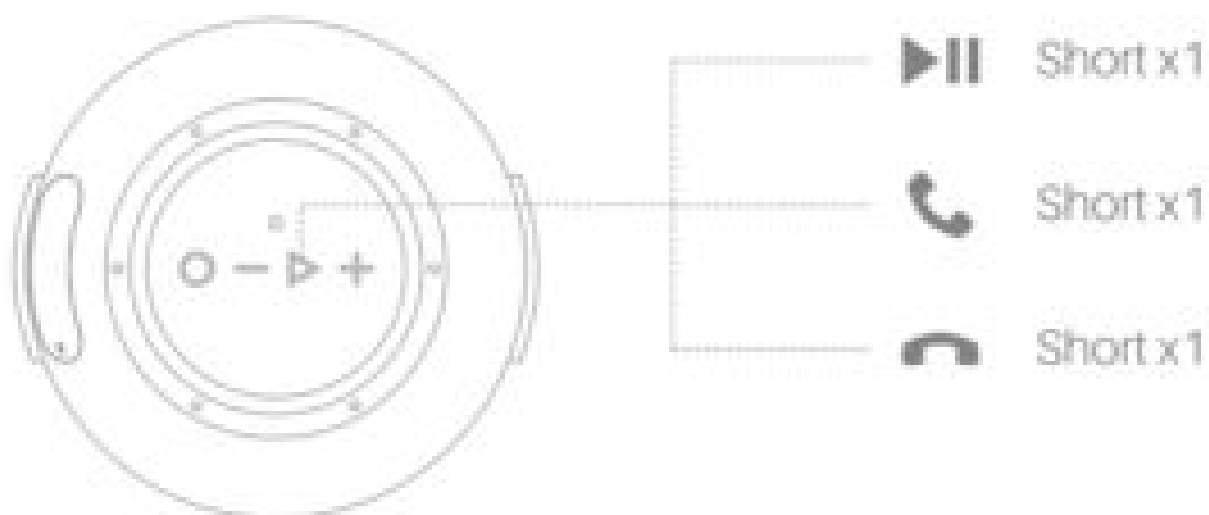
Enable your Bluetooth function of your smartphone search Bluetooth device and select "VTIN Q1" to connect.



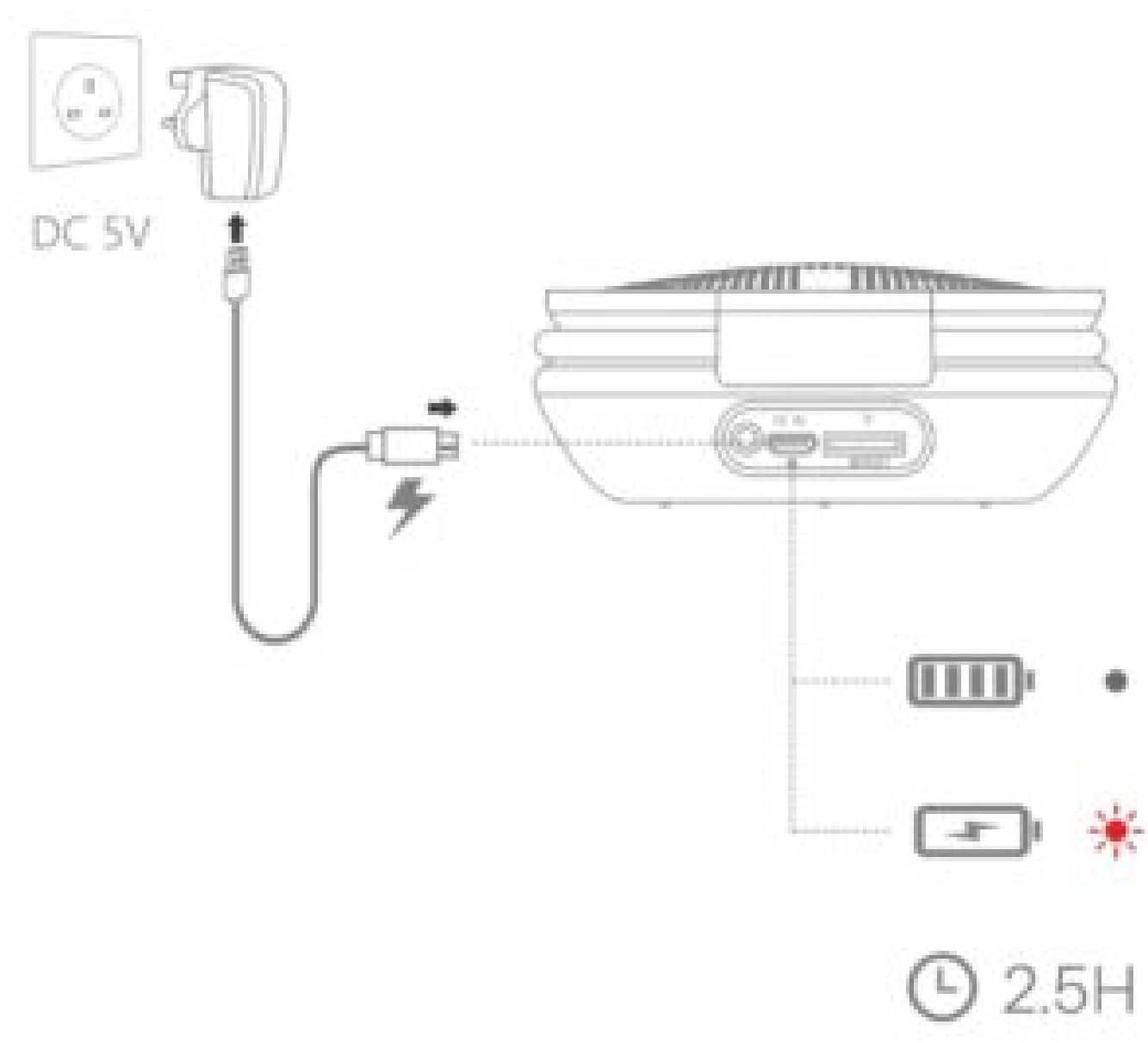
Volume Control/ Music Control

FCC STATEMENT
