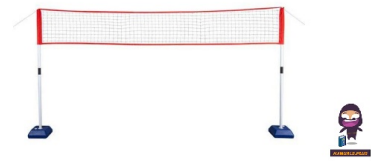

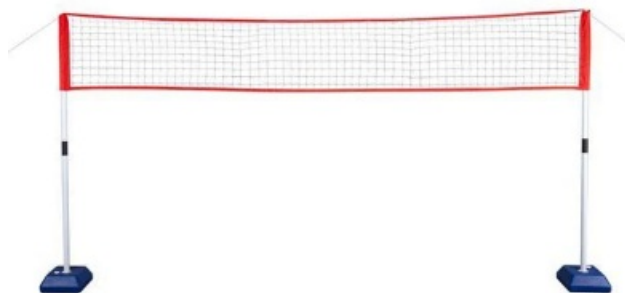

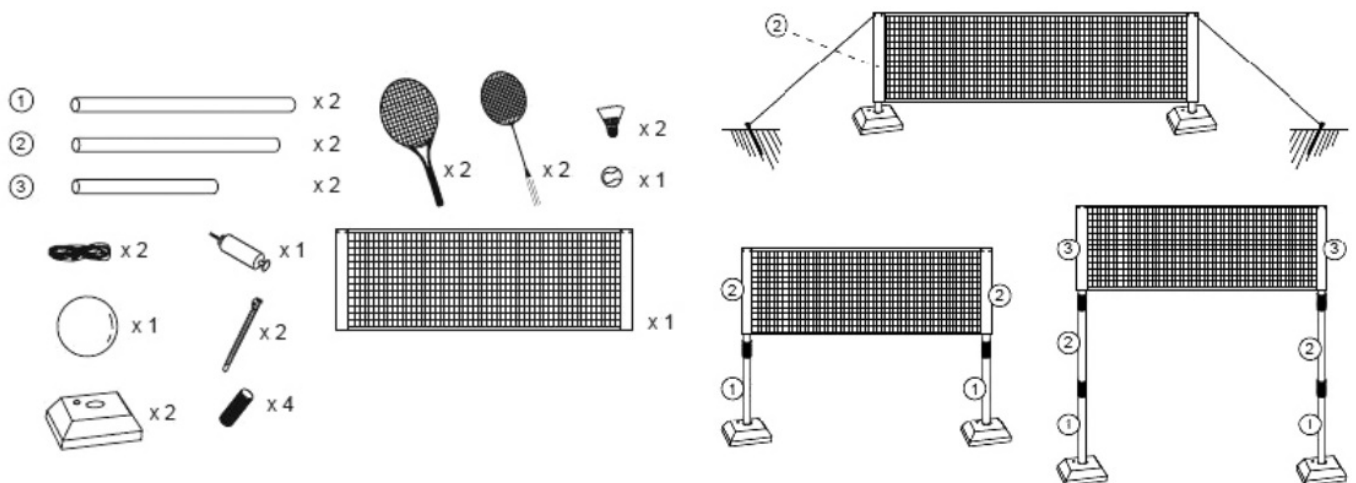
Product Information

- The product maintenance instructions include cleaning with a towel or wet cloth without using special cleaning substances. It is recommended to check for damages or signs of wear and tear before and after use. The structure of the product should not be altered, and only original spare parts should be used for safety.
- Upon reaching the end of its lifecycle, the product should be disposed of through waste collection and recycling systems by contacting local waste management representatives.
- The equipment is not intended for rehabilitation and therapy purposes.

Product Usage Instructions

1. **Cleaning:** Use a towel or wet cloth for cleaning. Avoid using special cleaning substances.
2. **Inspection:** Before and after using the product, check for any damages or signs of wear and tear.
3. **Modifications:** Do not make any changes to the product structure.
4. **Spare Parts:** Use only original spare parts for safety reasons.

WARNING!



- Before you start using the product, and periodically later, you should check and tighten all fastenings.
- In order to prevent injuries, the goal (net) must be secured so that it does not fall down.
- It is forbidden to climb the net and the goal frame (net and frame).
- “Swinging and hanging down” on the goal (net) is not permitted and can be dangerous.
- The product should be used according to its purpose.
- The product contains small component parts and should be kept away from children.

MAINTENANCE:

The product should be cleaned with a towel or wet cloth. No special cleaning substances should be used. Before and after using the product you check it for any damages or signs of wear and tear. No changes should be

made to the product structure. For your own safety, use only original spare parts.

INFORMATION ABOUT THE PRODUCT DISPOSAL

On termination of the product life cycle, the product should be transferred to the waste collection and recycling systems. To this end, you should contact your local representative of a waste management company.

GUARANTEE TERMS

1. The Seller provides guarantee on behalf of the Guarantor within the territory of the Republic of Poland for the period of 24 months from the date of sale.
2. The Guarantee will be recognised by the shop or service centre after the client provides:
 - clearly and correctly filled-in guarantee card with the sale stamp and the seller's signature – valid purchase confirmation for the equipment, including the date of sale/bill/ – complained product.
3. Possible defects and damages revealed during the guarantee period shall be remedied free of charge within not more than 21 days from the delivery of the product to the shop or service.
4. Should it be necessary to import some components, the guarantee term can be extended by the period required to import such part, however, such period shall not be longer than 40 days.
5. The guarantee does not cover:
 - mechanical damages and subsequent defects,
 - damages and defects resulting from incorrect storage and usage of the equipment against its purpose,- incorrect assembly and maintenance,
 - damages and consumption of such elements as: cables, straps, rubber parts, pedals, sponge grips, wheels, bearings, etc.
6. The guarantee expires in the event of:
 - expiry of the validity term,
 - self-repairs,
 - failure to follow the rules of correct operation.
7. No duplicates of the guarantee cards shall be issued.
8. The product handed over for repair should be complete and clean. If some parts are missing, the service is entitled to refuse to accept the product for repair. The service may refuse to accept a dirty product or clean in on the client's expense after the client's written permit.
9. The guarantee does not cover activities related to assembly, maintenance, which, according to the instruction, the user is obliged to perform themselves.
10. The Guarantor also informs that they offer post-guarantee service.
11. The product should be provided in its original packaging and should be secured for shipment.

The guarantee for sold goods is not exclusive, does not limit or suspend entitlements of the buyer resulting from the non-compliance of the product with the agreement.

FAQs

Q: What should I do if I notice any damages or defects during the guarantee period?

A: If any defects or damages are noticed during the guarantee period, they will be remedied free of charge within 21 days from the product's delivery to the shop or service.


Q: Can I extend the guarantee period if imported components are required for repair?

A: Yes, if imported components are necessary, the guarantee term can be extended by the time needed for import, up to a maximum of 40 days.

Q: Is post-guarantee service available for this product?

A: Yes, the Guarantor offers post-guarantee service for this product.
