#### Daily Use of the Camera from the App TUYA SMART

- · Playback: Play detected video events.
- Gallery: View captured photos and videos.
- Color Theme: Change app theme between light and dark modes.
- Private Mode: Turn off camera recording.
- · Night Mode, Infrared Mode.
- · Device Volume control.
- Motion Detection: Enable or disable motion detection.
- PIR: Activate or deactivate presence detection sensor.
- Siren: Activate or deactivate deterrent siren.

#### Camera Settings from the TUYA SMART App

- · Change device name.
- · Voice Assistant Settings.
- · Display device information in the cloud.
- · Assign scenes to the device.
- · Show Wi-Fi connection status.
- · Share the device with registered users.

# Frequently Asked Questions (FAQ)

#### Q: Can I use the camera without a Wi-Fi connection?

A: The camera requires a Wi-Fi connection for setup and regular operation. It does not work offline.

### ADD YOUR CAMERA TO THE MOBILE APP

### PRO TIP!

Before installing the camera on its final location, first, perform this setup near your Wi-Fi router and connect your mobile phone to the 2.4GHz Wi-Fi network to which you are going to connect the camera.

1. Download one of the two compatible apps, TUYA SMART or SMART LIFE on your app store, or scan the corresponding QR code:










- 2. Sign up for a new account or log in if you already have one.
- 3. Click on the + icon and select "Add device".
- 4. On the left column, select "Camera & Lock" and then "Smart Security Camera (Wi-Fi)".
- 5. Connect the camera to its power supply and wait a few seconds until you see the camera's LED flash and you hear a continuous "beep" sound. You may need to press the Reset button on the camera for more than 5

seconds for it to reboot and activate its "Connection Mode" again.







- 6. The cell phone must be connected to a 2.4Ghz wifi network.
  - 1. Remove the lens protector.
  - 2. Press the reset button on the camera.









- 7. Enter the password for your Wi-Fi network.
  - 1. Place the QR code that has been generated in front of the camera so that the camera can read it and connect to the Wi-Fi network.
  - 2. Once you've heard the double tone, press the "I heard the warning" button.
  - 3. A two-minute on-screen countdown will begin, during which time the app will search for the camera and add it to the app.












# **FEATURES**

- 1. Playback > Allows you to play the detected video events.
- 2. Gallery > Shows the captures of photos and videos recorded from the app on the mobile.
- 3. Color Theme > Allows you to change the color theme of the app in light mode and dark mode.
- 4. Private Mode > When activated, the camera will be turned off and will not record video
- 5. Nightmode, Infraredmode.
- 6. Devicevolumen.
- 7. Motion Detection > Enables or disables this function.
- 8. PIR > Activates or deactivates the presence detection sensor.
- 9. Siren > Activates or deactivates the deterrent siren




### **SERVICE HALL**

It is a function under paid subscription, which allows you to monitor and supervise the operation of the camera
in the event of the loss of the video or if the device has been turned off, if it detects any of these events the
Tuya Smart app will notify the error that the camera presents so that the user can check the status of the
camera.




# **CLOUD**

1. It is a service under subscription of monthly or annual payment and allows you to store events or video recordings in the cloud, these recordings will always be accessible to the customer from the Tuya Smart App.




- 1. Allows you to change the name of the device.
- 2. Voice Assistant Settings.
- 3. Display device information in the cloud.
- 4. Allows you to assign previously created scenes.
- 5. Shows the connection status of the device on the Wi-Fi network, whether signal strength with the camera is weak or strong.
- 6. It allows you to share the device with third parties, the person must be previously registered in the Smart app to be able to share the device.
- 7. It is a paid service and allows you to create personalized notifications through calls and SMS messages about the status of the device and detections.

- 8. Private Mode > When activated, the camera will be turned off and will not record video.
- 9. It allows you to configure image rotation, watermark, two-way audio mode and camera calibration.




