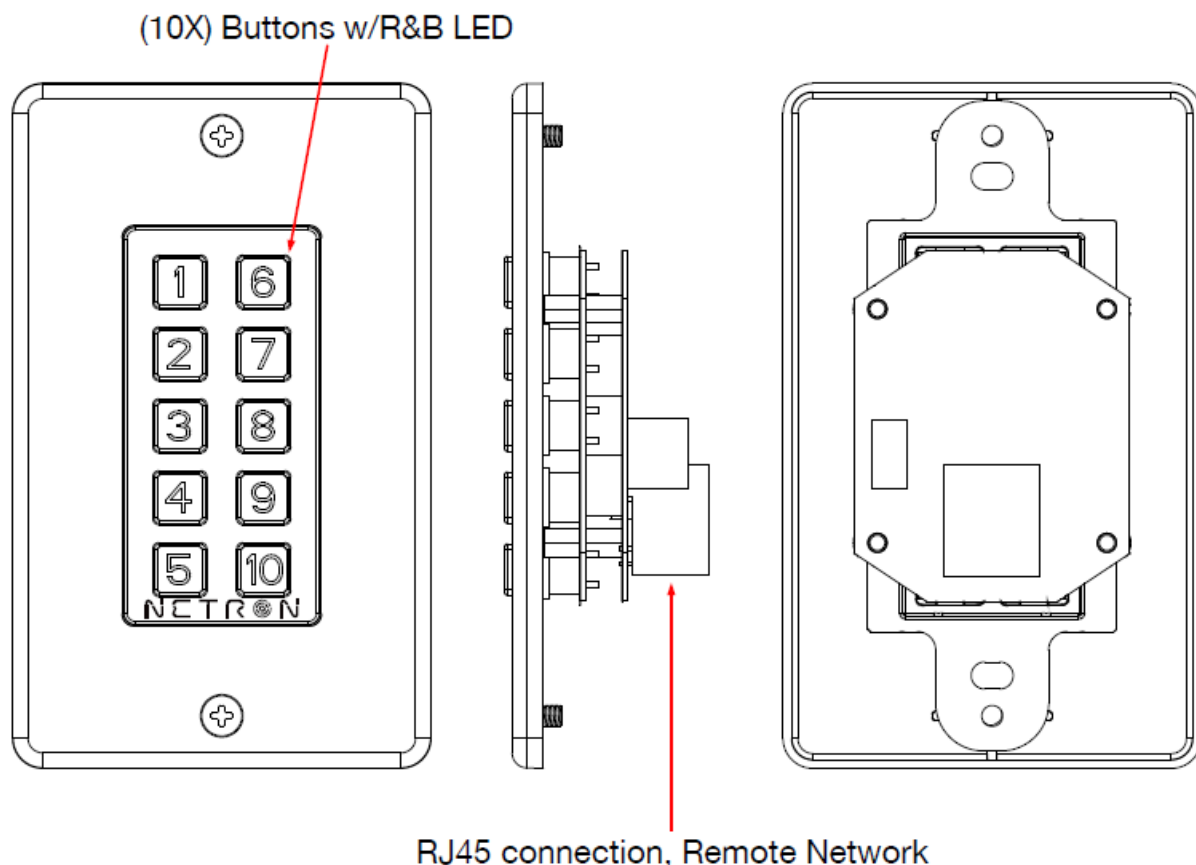

OVERVIEW

The NETRON BS10 is an elegant wall station for cue or preset recall from the EN12i EtherDMX Node. 10 Backlit and numbered buttons provide easy feedback, and the RJ45 connection combines power and data for simple and efficient connectivity to the NETRON node over standard CAT5 wiring.

ETHERNET DATA CONNECTION

The Ethernet cable is connected on the back of the BS10 device. The BS10 employs a proprietary data protocol, rendering it incompatible with conventional Ethernet devices such as switches or personal computers. Attempting to connect the BS10 or NETRON device to standard Ethernet equipment may result in damage, and such incidents are not covered by the warranty. Please note that the BS10 supports a single direct connection exclusively to an EN12i.

ELECTRICAL CONNECTIONS

A qualified electrician should be used for all electrical connections and/or installations.

Device **MUST** be installed following all local, national, and country commercial electrical and construction codes and regulations.

MOUNTING OPTION:

- 1-Gang In-wall with included Decora cover plate

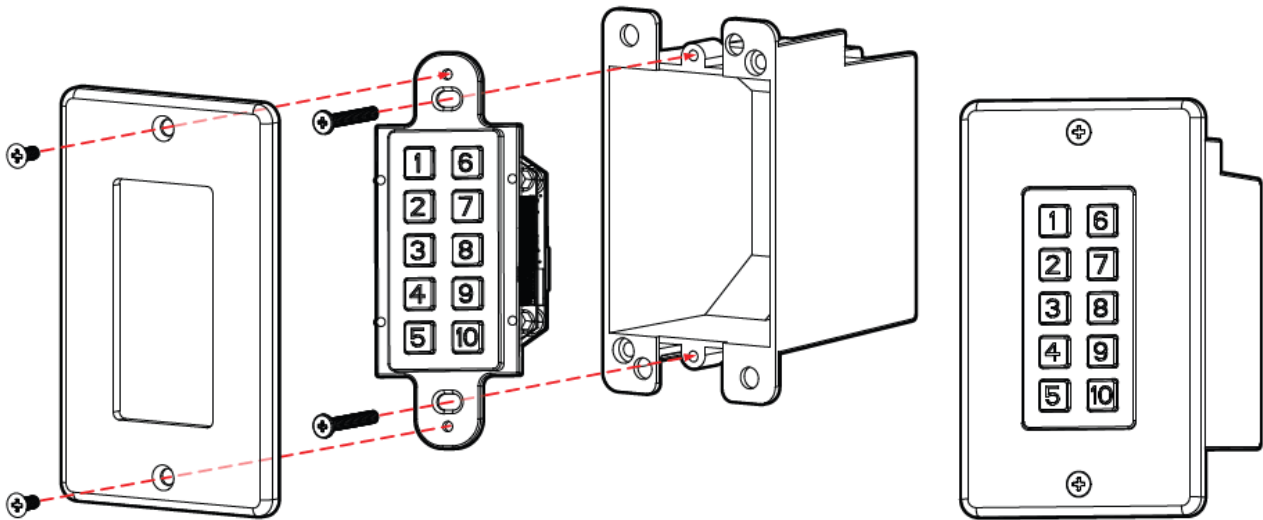
Wall-Mount/Panel Installation:

1. Mount and secure the integrated mounting-bracket to the junction-box with (2x) screws.



All wiring and connections must be performed by a qualified electrician.

2. Secure the cover plate to the junction box with (2x) screws.



MAINTENANCE

The Obsidian Control Systems Netron BS10 is designed as a rugged device. The only required service is occasional cleaning. For other service-related concerns, please contact your Obsidian Control Systems dealer, or visit www.obsidiancontrol.com. Any service that is not described in this guide must be carried out by a trained and qualified Obsidian Control Systems technician. As any controller, the BS10 requires periodic cleaning. The schedule relies on the environment in which the controller is operated. An Obsidian Control Systems technician can provide recommendations if necessary.

Never spray cleaner directly onto the device surface; always spray into a lint-free cloth and wipe it clean. Consider using cleaning products designed for cellphone and tablet devices.



Important! Excessive dust, dirt, smoke, fluid build-up, and other materials can degrade the performance

of the BS10 device, causing overheating and damage to the unit that is not covered by the warranty.

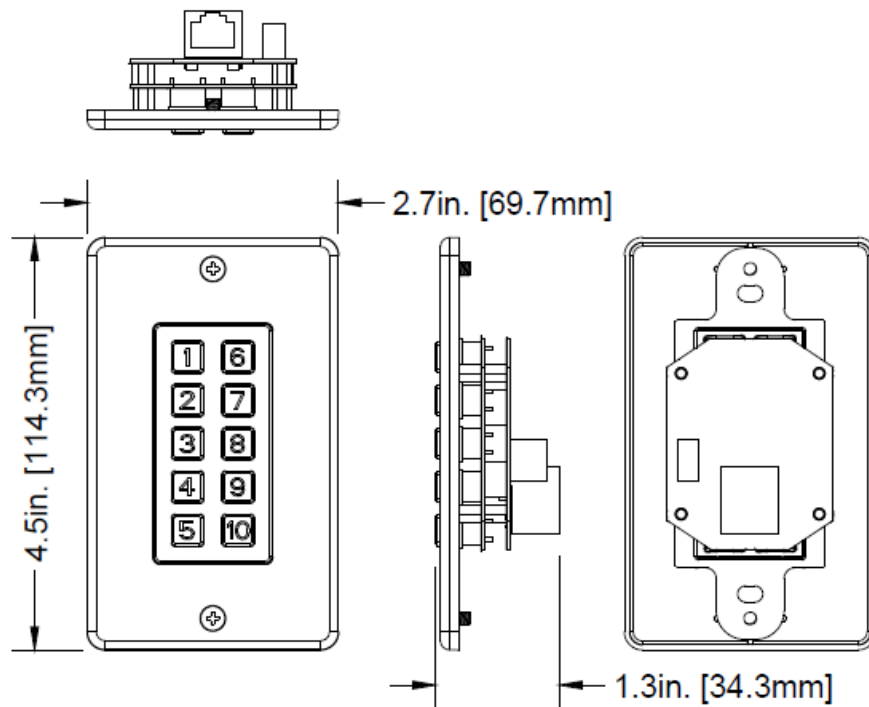
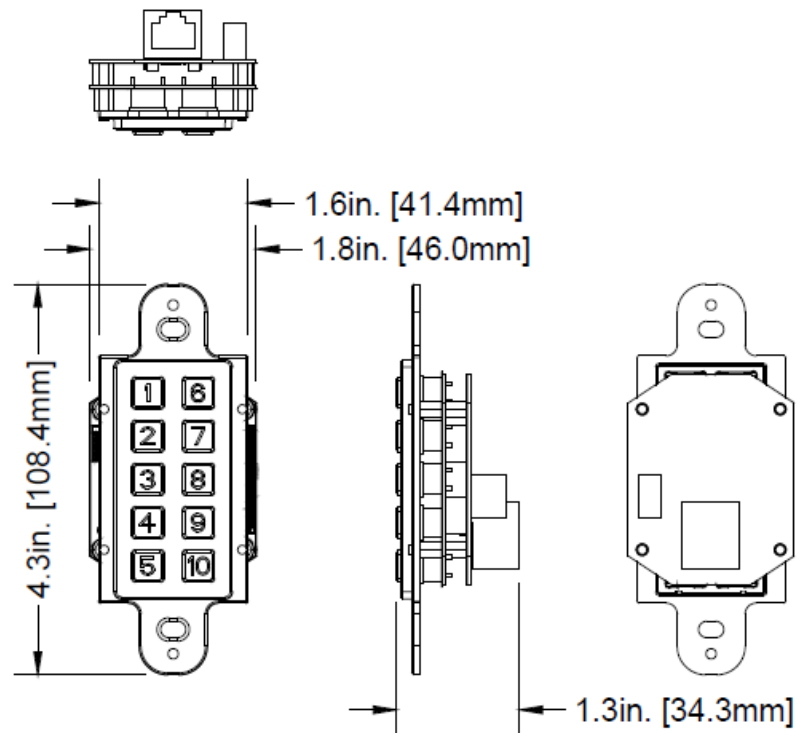
