Product Information

Carousel

The Carousel is a machinery used for rotating objects in a designated area. It is designed to safely handle loads

within specified weight limits. The Carousel features red stop buttons for emergency shutdown and a brake system for loading and unloading rolls. It is important to follow the operating and safety instructions provided in the attached label/manual to ensure safe usage.

Product Usage Instructions

- 1. Locate the red stop buttons on the Carousel.
- 2. Only the designated operator should be allowed in the operating area when the Carousel is in operation. This restriction is in place to ensure safety.
- 3. Prior to applying the brake or loading rolls, ensure that the Carousel is switched off.
- Refer to the attached label/manual to determine the maximum weight limits for loading on the Carousel bars.
 Do not exceed these limits.
- 5. Avoid wearing loose clothing and keep hands and hair clear when the Carousel is rotating.
- 6. Only operate the Carousel if you have received proper training or are being supervised by someone who is trained.

You also agree to wear the required personal protective equipment (PPE) when using the Carousel and take necessary precautions for your own safety. If further training is required or if any issues with the machinery arise, promptly inform the Supervisor or Manager.

6	Do not operate unless fully trained or being supervised.
