



# Instructions

# **Product description:**

Pod: see page 2, figure A

1. Interactive tap zone

2. Charging Pogo pins

Charging base: see page 2, figure B

1. Pod stack charging area

2. USB-C charging port

How to install: see page 2, figure D

# How to charge:

• To charge de Pods, plug a USB charging cable into a USB power adapter (not included) and into the product's

charging port.

- Stack the 4 Pods on the charger (see page 2, figure C).
- The Pods will blink red to indicate that they are charging and will gradually turn green until the battery gets fully charged. When they are all charged, the Pods will all blink green.

#### How to use:

This product is App-controlled.

Scan the QR code to download the App from the Apple App Store or the Google Play Store. You can also download the app from our website: <a href="https://www.prozis.com/fitnesstracker">www.prozis.com/fitnesstracker</a>





Sign in to the App.

#### Pairing product and mobile device:

- Your Pods are in suspend mode. Prior to first use, place the Pods on the base until they blink with 3 colors.
- Remove them from the base. Your Pods are now in pairing mode.
- Open the ProzisGo App, press the device button displayed at the bottom of your dashboard screen, and then press "+" to add a device. Select the intended device and follow the instructions.
- Once a connection is established, each Pod will blink blue 3 times. If you take more than 2 minutes establishing a connection, they will blink white, which means they returned to suspend mode.
- On the App you can choose different workout activities according to your own fitness goals or preferences.

**NOTE:** The Pods must be paired to your smartphone using the ProzisGo App, each time you use them. These will enter suspend mode after 5 minutes of inactivity.

#### Reset

Once you pair the Smart Dots with your smartphone, they will be locked to that device.

To perform a reset place each Pod on the charger for about 10 seconds and shake them (up and down) until they blink with 3 colors.

Your Pods are now in pairing mode.
