This product is a product of an intelligent lock controller, which is the control part of the intelligent lock on shared scooters.



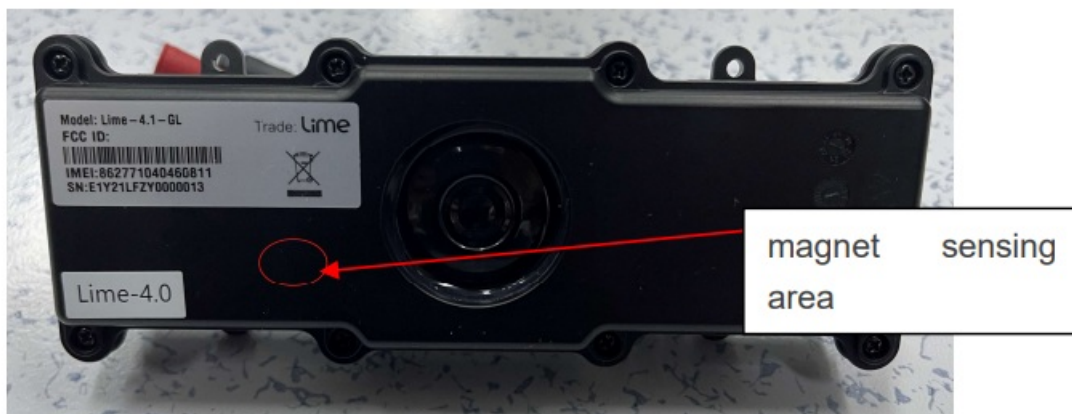
Hardware interface

The magnet must be close to the induction area to open the machine.



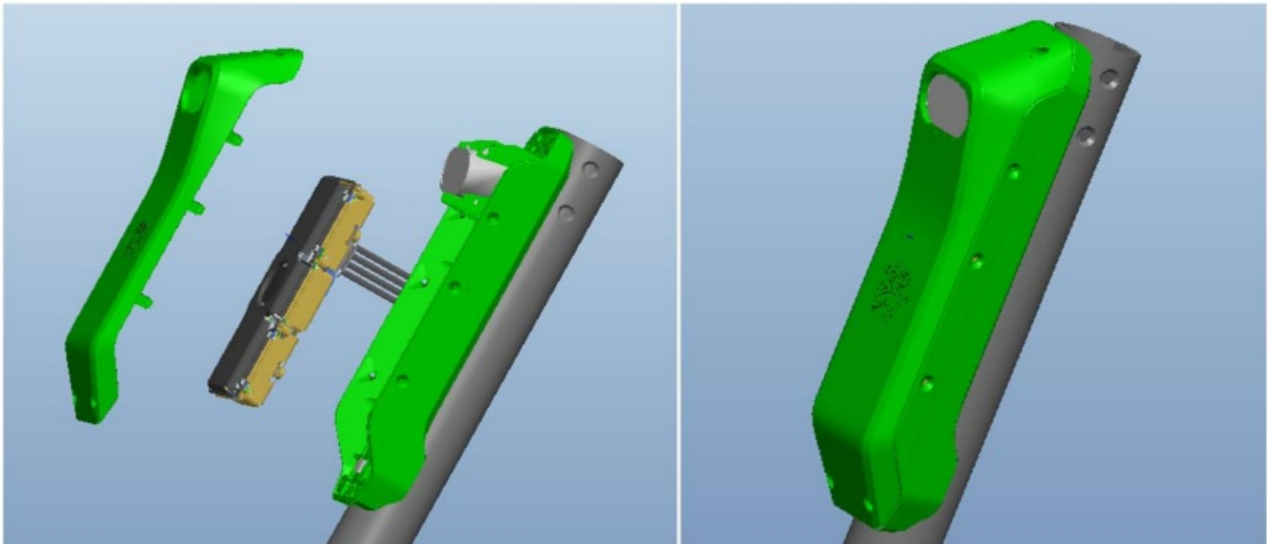


