
## RAND MCNALLY FLEET Rand Platform Android Vehicle Link User Guide



Thank you for being a Rand McNally customer. The aim of this quick start guide is to get the Vehicle Link installed in your truck and the companion app connected and working.

- 1. Make sure your vehicle is turned off
- 2. Locate the diagnostic port which is typically found in one of the following places:
  - · Above the footrest
  - · Under the dashboard or steering column
  - On the left or right of the pedals
  - · Under the driver's seat
  - In the fuse box
  - · Near the handbrake
- 3. Plug the Vehicle Link into the 9-pin connector.
  - Turn the outer ring clockwise until the device is securely in place.
- 4. Please contact Rand McNally at 800-641-7263 if your vehicle connector has something other than a 9-pin configuration.
- 5. Turn on your vehicle.
- 6. When the vehicle connection is detected by the Link, the light will change from red to green.

- 7. The device will pulse white while initiating connection to GPS and continue to pulse through white, blue, and green as Bluetooth becomes discoverable.
- 8. Next you need a Rand McNally app. You can use your own Android phone or tablet.
  - On a phone or tablet go to the Google Play store and search for "Rand VL App".
    Download and install the app.
- Open the Rand VL App on your phone or tablet.
  Follow the on-screen steps to pair the Rand VL App with the Vehicle Link, and to register your company with Rand McNally. Your Vehicle Link will appear as "RM VL + your ELD's unique ID" in the list of available devices.
- 10. The device will show a pulsing green light to indicate the successful completion of the installation.

# **Warranty and Disclaimers**

RM Acquisition, LLC d/b/a Rand McNally warrants that the product, and the component parts thereof, will be free of defects in workmanship and materials for a period of one (1) year from the date of purchase. This warranty may be enforced by the first consumer purchaser ("Customer"), provided that the product is utilized within the U.S.A. or Canada.

During the warranty term, Rand McNally will, without charge, repair or replace (with a new or newly reconditioned unit), at its option, defective products or component parts. For repair or replacement of defective products, Customer must contact Rand McNally at 800-641-7263 for return authorization and instructions. Customer will be required to have the product registered via the Rand VL App or, if Customer is unable to register the product electronically, Customer will be required to provide proof of date of first Customer purchase, such as a duplicate copy of the original sales receipt, for the warranty to be valid. The Customer must pay any initial shipping charges required to ship the product for warranty service, but the return charges will be at Rand McNally's expense, if the product is repaired or replaced under warranty.

If the product sent in is still under its original warranty, then the new warranty is 90 days or to the end of the original one (1) year warranty, whichever is longer. If the Product is out of warranty, Rand McNally shall have no obligation to repair or replace the Product, but if it does choose to repair or replace the Product (i) Customer shall be responsible for the cost of such repair or replacement at Rand McNally's then-current cost and for all shipping charges associated with shipment of the Product to Rand McNally and its return to the customer, and (ii) the repaired or replaced product shall be warranted for 90 days.

This warranty gives the Customer specific rights. Other rights may be available to Customer which vary from state to state.
