




- **A:** Num Lock indicator

## Status LED

1. Capslock indicator: The indicator keeps on while uppercase letters are in use, and turns off when switched to lowercase letters.
2. Charging indicator lamp: the red light will be lit for a long time when charging and the red light will be put out when fully charged.
