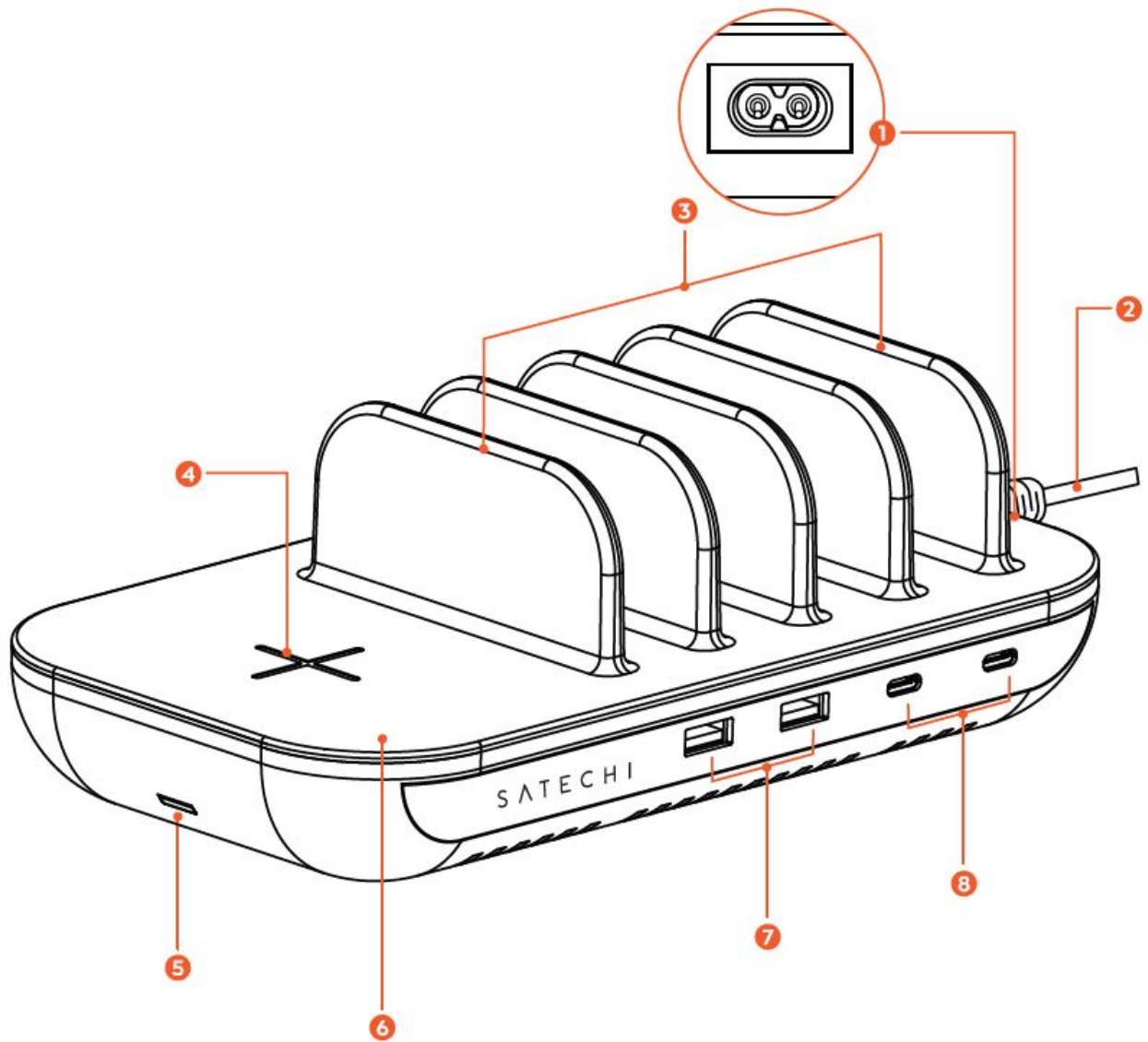

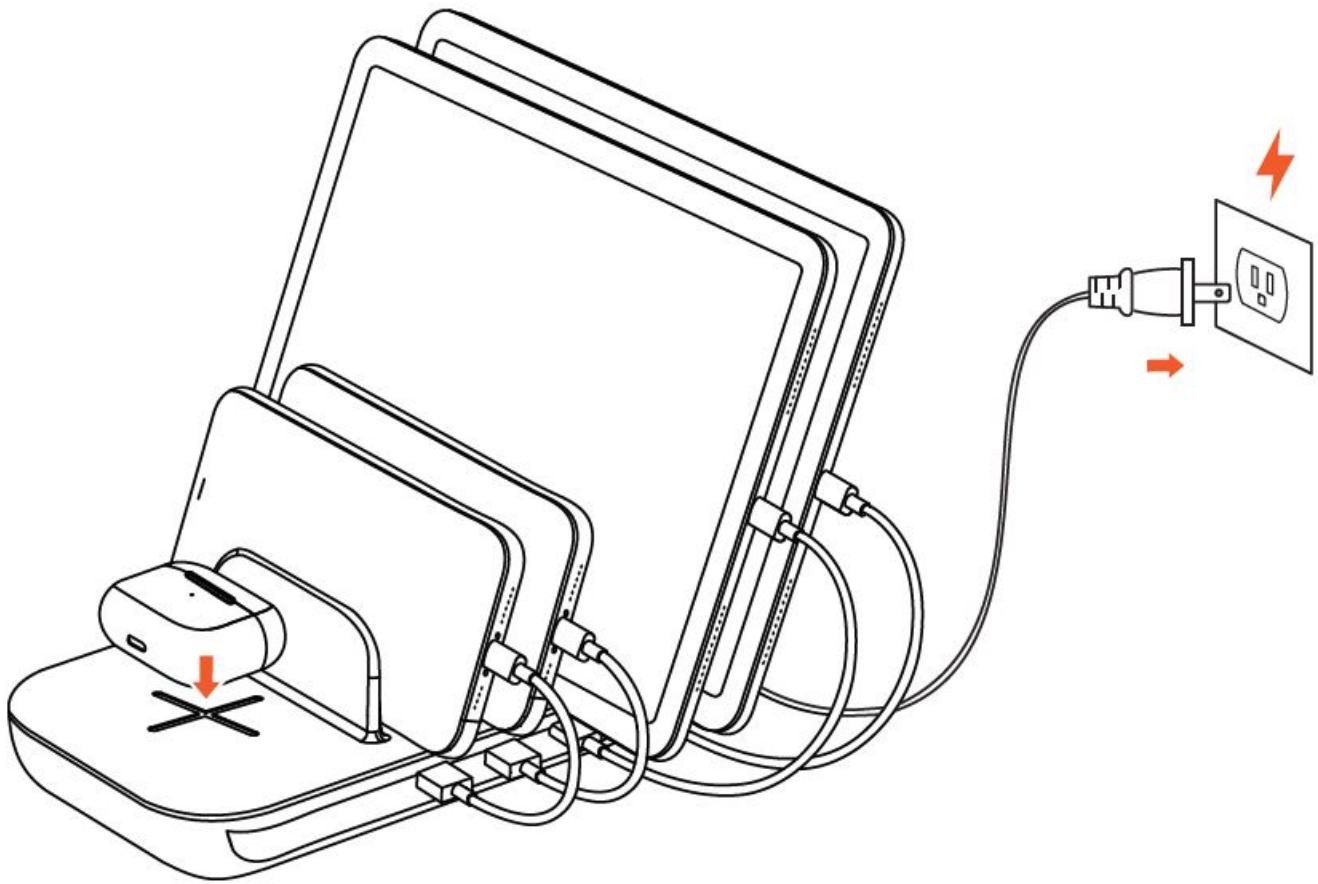


## FUNCTIONS
