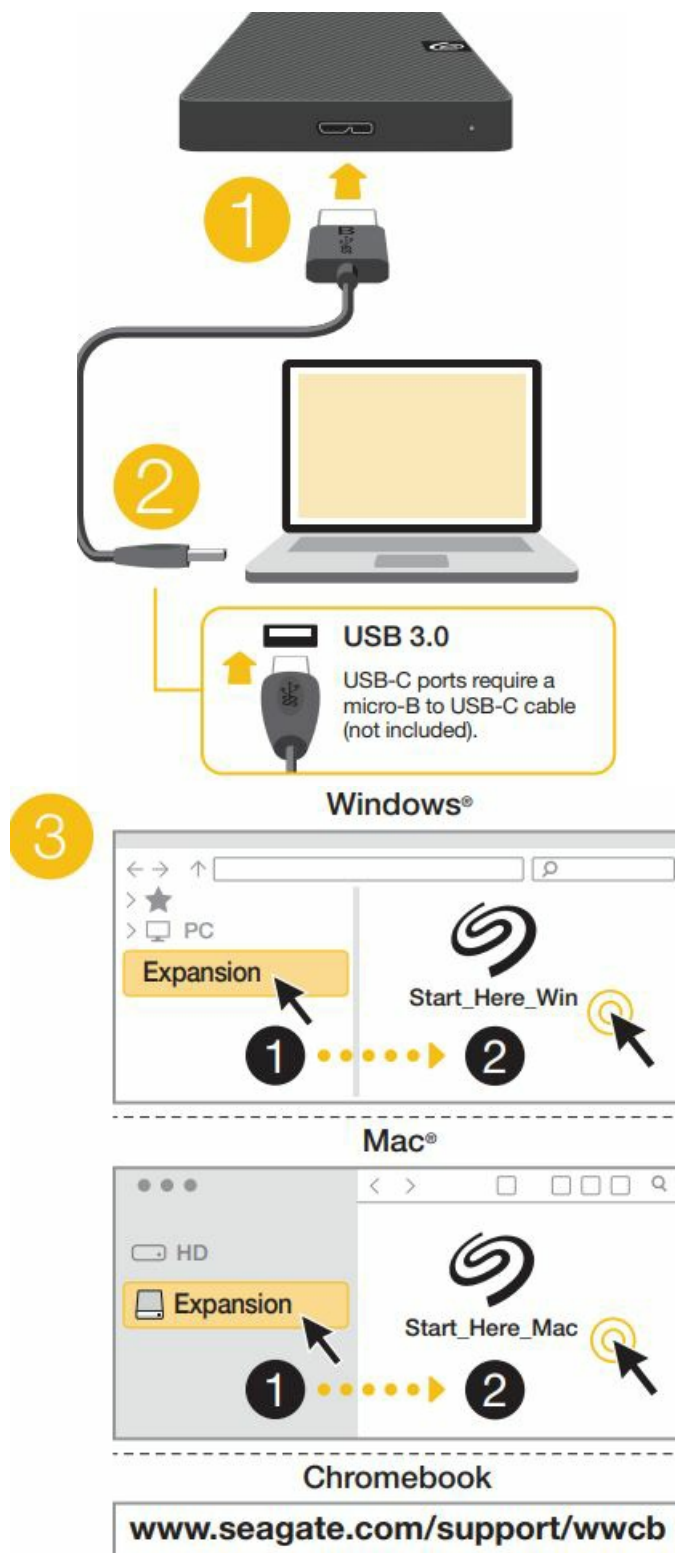


Product Information

- The product is an Expansion External Drive manufactured by Seagate. It features USB 3.0 connectivity and is compatible with both PC and Mac.
- The drive comes preformatted with exFAT file system, allowing it to be used seamlessly on both PC and Mac. However, if you want to use it with Time Machine on Mac, you need to reformat the drive specifically for Mac, which will erase all data stored on it.
- The product is also certified to meet Google's compatibility standards and is compatible with Chromebook devices.
- It is important to follow safe removal procedures for your operating system when disconnecting the product in order to protect your data.
- The product comes with a warranty, and you can review the details of the warranty by opening the Seagate Limited Warranty Statement on the drive or visiting www.seagate.com/warranty. For warranty service, you can contact an authorized Seagate service center or visit www.seagate.com/support/expansion-portable/ for more information regarding customer support in your jurisdiction.
- The device complies with Part 15 of the FCC Rules and has been tested to meet Class B digital device standards, providing reasonable protection against harmful interference in residential installations.

Product Usage Instructions

1. To connect the drive to a USB-C port, you need a micro-B to USB-C cable (not included).
2. For PC users, refer to the "Start_Here_Win" document located on the drive for initial setup instructions.
3. For Mac users, refer to the "Start_Here_Mac" document located on the drive for initial setup instructions.
4. If you want to use the drive with Time Machine on Mac, it must be reformatted specifically for Mac. Keep in mind that reformatting will erase all data on the drive.
5. For Chromebook users, visit www.seagate.com/support/wwcb for more information on compatibility and usage.
6. Always follow the safe removal procedures for your operating system when disconnecting the product to protect your data.
