

FUNCTIONS

- Temperature °C/°F selectable.
- Resolution 0.1°C, Outdoor temperature range: -20°C ~ +60°C
- · Low voltage indication
- 1 functional keys C/F, click to switch between °C/°F
- Power voltage: 2.5V-3.3V
- Static Current: <30uA

POWER ON OR RESET

- 1. After power on, LCD full display for 3s, followed by temperature sampling and then enter into moral mode. It will check temperature and send date to receiver before synchronizing period ends.
- 2. Default temperature unit: °C
- 3. Default channel after power on is CH1

OPERATION INSTRUCTION

Click "C/F" to switch between °C/°F

433 MHZ RECEPTION CHECK

The transmission range is about 30 meters from the transmitter to the thermometer (in open area). The thermometer should receive the temperature data with 3 minutes after set-up. If the temperature data is not received 3 minutes after setting up, please check:

- 1. The distance of thermometer or transmitter should be at least 5~6.5 feet (1.5~2 meters) away from any interfering sources such as computer monitors or TV sets.
- 2. Avoid positioning the thermometer onto or in the immediate proximity of metal window frames.
- 3. Using other electrical products such as headphones or speakers operating on the same signal frequency.
- 4. Neighbors sing electrical devices operating on the same signal frequency can also cause interference.

POSITIONED METHOD

The sensor can be placed in bellow 2 ways.

- A. Pull out the stand bracket on the bottom of sensor and place on balcony.
- **B.** Hang on wall outside of house by hanging hole.

PRECAUTIONS

- 1. Do not clean any part of the product with benzene, thinner or other solvent chemicals. When necessary, clean it with a soft cloth.
- 2. Never immerse the product in water. This will damage the product.
- 3. Do not subject the product to extreme force, shock, or fluctuations in temperature or humidity.
- 4. Do not tamper with the internal components.
- 5. Do not mix new and old batteries or batteries of different types.
- 6. Do not mix alkaline, standard or rechargeable batteries with this product.
- 7. Remove the batteries if storing this product for a long period of time.
- 8. Do not dispose of this product as unsorted municipal waste. Collection of such waste separately for special treatment is necessary.

Warranty conditions

This product is warranted for the period of 24 months from the date of purchase to the end-user. warranty is limited to the following conditions. warranty is referred only to the customer goods using for common domestic use. The claim for service can be applied either at dealer's shop where the product was bought, or at below mentioned authorized service shops. The end-user is obligated to set up a claim immediately when the defects appeared but only till the end of warranty period. The end user is obligated to cooperate to certify the claiming defects. Only completed and clean (according to hygienic standards) product will be accepted. In case of eligible warranty claim the warranty period will be prolonged by the period from the date of claim application till the date of taking over the product by end-user, or the date the end-user is obligated to take it over. To obtain the service under this warranty, end-user is obligated to certify his claim with duly completed following documents: receipt, certificate of warranty, certificate of installation.

This warranty is void especially if apply as follows:

- Repair, modification or other failure action to the product by unauthorized person.
- End-user did not prove enough his right to claim (time and place of purchase).
- Data on presented documents differs from data on products.
- Cases when the claiming product cannot be identified according to the presented documents (e.g. the serial number or the warranty seal has been damaged).
