## Product Overview

1. Volume down/Last Song
2. Power On/Off
  - Answer/End/Reject/Recent Call
  - Play/Pause
  - Voice assistant
3. Volume up/Next Song
4. Microphone
5. Type-C Charging Port
6. Headphone port
7. Device Pairing LED



## Basic Operations:

Please ensure the headset is fully charged before use.

### 1. Bluetooth Pairing/Connection

1. Turn on the product. Bluetooth mode will be activated automatically – the default setting is Bluetooth pairing mode, not ANC mode.
2. Enable bluetooth function on your media device.
3. Search the bluetooth device named BTA010 and select BTA010 to connect (pair).
4. After successful connection, you will hear "your bluetooth device is connected." Now you can play music, or use bluetooth phone functions.

### 2. Music Playback Functions



- Power on: Long press the button for 3 seconds.
- Power off: Long press the button for 5 seconds.
- Play/Pause: Short press the button.
- Answer call/End call: Short press the button.
- Reject phone call: Long press the button for 2 seconds.
- ANC on: Double click the button, green light is on.
- ANC off: Double click the button, green light is off.
- Voice assistant: for smartphones with voice assistant and successful connection with device: Three click the button.



- Next song: Long press the button.
- Volume up: Short press the button.
- Previous song: Long press the button.



- Volume down: Short press the button.

## Cables included

### 1. 3.5mm Auxiliary cable



Standard 3.5mm AUX cable included. Allows you to use the wireless headphone with wired audio devices. Just plug the AUX cable into any 3.5mm stereo output jack. When the headphone is under bluetooth mode, plug the aux cable, the headphone will be power off automatically and enter the “AUX mode” When the headphone is under AUX mode, the button is no actual functions.

### 2. TYPE-C USB, DC 5V USB



#### To charge device:

Plug the provided USB-C® charging cable into the charging port on your headset and plug the large end into the usb port on a computer, or usb adapter (not included). It may take up to 5 hours to charge the device. When the headphone is turned on and plugged in the charging cable, it will be automatically shut down without any voice prompts and it can't work while charging. When charging, a red light is on and still, and when fully charged, the light is turned off
