


Introduction:

- 3. TYPE-C Female




Operation instructions:

2.1 Bluetooth headset charging When charging the Bluetooth headset, first turn the apple head of the Bluetooth headset to stand upright, then plug the Bluetooth headset into the position of the apple head of the headset to charge and see that the charging indicator of the Bluetooth headset lights up, indicating normal charging.






2.2 iWatch charging method: (1) The iWatch wireless charging pad is placed flat to charge the iWatch. (2) Put the iWatch wireless charging pad to the vertical position to charge the Match.



- 2.3 iWatch charging: Put the 'Watch on the wireless charging area of the watch align the magnetic attraction, and the watch will light up the "charging sign" indicating that it is charging normally.
- 2.4 This product needs to be powered by an adapter with a power 5V/1A–2A, and is connected to the Type-C port for the power supply

- 4.1 When charging. please insert the device and the iPhone plug-in correct place to prevent the device from not charging
- 4.2 Do not put metal or foreign objects in the charging area of the Watch to prevent the device from not charging.
- 4.3 This product only compatible with 'Watch and Airpods
