Shenzhen Enzo Technology RMT-TX100U Remote Control



Function Button

POWER: Press to turn on and off the TV.

INPUT: Selects the video source.

Color Buttons(YELLOW/BLUE/RED/GREEN/): Shortcut keys for interactive functions

●: Press to select the digital sub-channels. For example, to enter "63-5", press "63", "●", and then "5".

 **Accesses the "NETFLIX" online service.**

DISPLAY: Display the playback and web browsing(BDP-3200 BX320/S5200/BX520 only) information on the screen.

BACK: Return to the previous step.

HOME: Enters the plays's home menu Displays the wall paper when pressed on the category icon of the home menu.

GUIDE: Displays and Electronic Program Guide.

VOL+/-: Adjusts the volume.

CH+/- : Changes channels.

AUDIO: Selects the language track when multi-lingual tracks are recorded on BD-RoMs/DVD VIDEOS. Selects the sound track on CDs.

SUBTITLE: Selects the subtitle language when multi-lingual subtitles are recorded on BD RoMs/DVD VIDEOS.

PREV/NEXT: Skips to the previous/next chapter track, or file.

STOP: Stops playback and remembers the stop point(resume point). The resume point for a title/track is the last point you played or the last photo for a photo folder.
