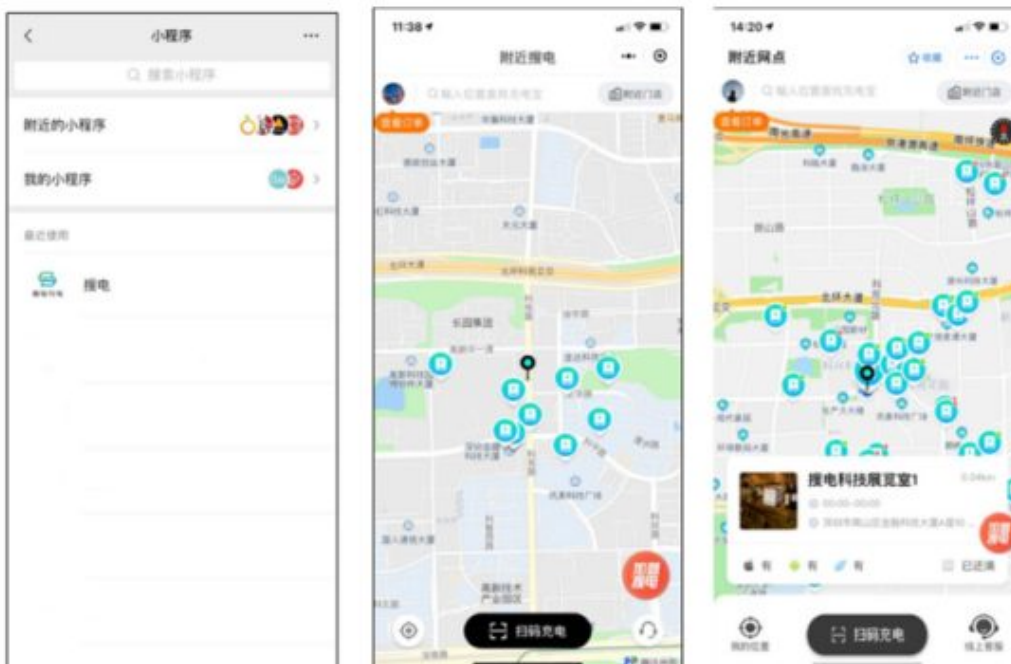

The power line of the cabinet can be connected to the power supply, the cabinet can be started, and the charging treasure can be put into the card slot.

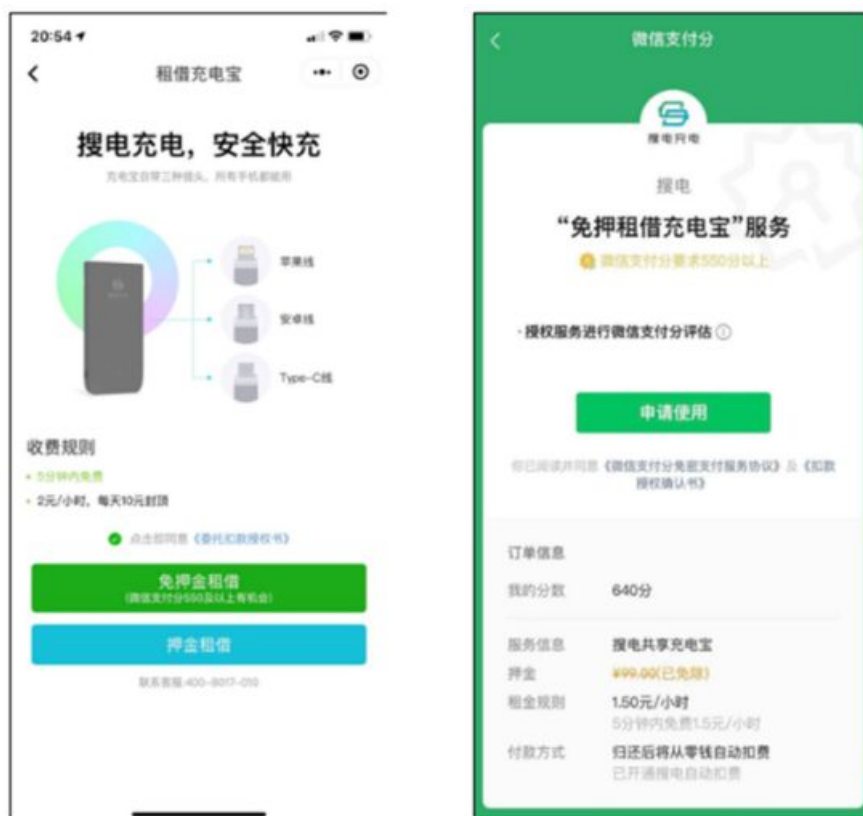


The small program searches electricity into the way WeChat click -> +. Scan -> scan QR code -> search electricity rental equipment into the small program; By scanning the two-dimensional code of the cabinet/equipment, you can directly enter the interface of renting charging treasure. Note: Equipment types can be divided into the cabinet, Eight treasure, Color treasure, three treasure, password line; These operational guidelines to rent color treasure examples.

In WeChat-> found > small program, which searches power to find and open;  
After opening the applet, you can view the nearby shops and shops that can be rented and the remaining slots that can be rented. Click and go to rent. Note: enter search electric small program for the first time need to get your location information, such as refusing to get the position, will not be able to use the map function, can't see can rent shops nearby sites, can only by scanning bar codes on loan equipment.



Charging treasure to loan from the deposit loan WeChat pay > 550, and have been merchants from deposit payment functions click from the deposit loan, enter WeChat pay tabs, apply for to use WeChat pay points “no foregift borrow charging treasure” service; Note: The charge rules are determined by the shop, there is no uniform regulation.



Deposit loan deposit prepaid phone after clicking the “back” button, enter the charging treasure on loan in the page; The deposit will be displayed in my wallet in the user center. Note: The amount of deposit on the actual rental page shall prevail.



Return on loan after the completion of the equipment, please charge treasure according to the directions into the empty slots, waiting for your order prompt has been completed and can be successfully left the scene; If you have any questions, please contact the store management staff/consult online customer service/call the 400 customer service hotline.
